**PATENT OWNER'S REQUEST FOR ORAL HEARING**

In accordance with 37 C.F.R. § 42.70(a), requiring a separate paper requesting oral hearing and specifying issues to be argued, and the August 28, 2017 Scheduling Order (Paper 12), Patent Owner Rovi Guides, Inc. ("Patent Owner") respectfully requests the opportunity to present oral argument on the following issues:

- Patentability of claims 1–24 of the '595 patent on the ground of obviousness over Young '121, Granger, and Browne;
- Patentability of claims 1–24 of the '595 patent on the ground of obviousness over Browne, Young '268, and Granger;

- Any issues of claim construction;
- Rebuttal to Petitioner's presentation on all matters; and
- Any additional issues on which the Board seeks clarification.

The two related proceedings for U.S. Patent No. 8,713,595—IPR2017-00866 and IPR2017-00867—are each scheduled for oral argument on the same day. To address the disputed issues, Patent Owner respectfully proposes a combined hearing with an allocation of one hour of time per side for arguing the collective grounds of IPR2017-00866 and IPR2017-00867.

Furthermore, Patent Owner requests the ability to use audio/visual equipment, including an ELMO, laptop, projector, and screen, to display demonstratives and exhibits at the oral hearing.
