DECISION
Granting Patent Owner's Motion for Withdrawal of Counsel

FURTHER ORDERED that Robert P. Greenspoon is recognized as Patent Owner's back-up counsel for this proceeding; and

FURTHER ORDERED that Patent Owner must designate a new lead counsel within five (5) business days of the date of this Order.
