- Any other outstanding motions and pleadings, and other issues that the Board deems necessary for issuing a Final Written Decision.

Should Align continue trial, Align requests the ability to use audio visual equipment to display possible demonstratives and exhibits, including the use of an ELMO, computer, projector, and screen.
