**PETITIONER'S REQUEST FOR ORAL ARGUMENT**

Pursuant to 37 C.F.R. § 42.70 and the Board's Third Revised Scheduling Order dated September 16, 2020 (Paper No. 55), Petitioner Samsung Electronics Co., Ltd. ("Petitioner") requests oral argument. Petitioner notes that Patent Owner NuCurrent's request for oral argument is limited to substitute claims 40-44 of U.S. Patent No. 8,710,948 ("the '948 patent") in the Revised Motion to Amend. Given this limited request, Patent Owner's limited arguments as to the original claims, and Patent Owner's failure to file a sur-reply with respect to the original claims, Petitioner believes the proceeding is now effectively limited to the patentability of the proposed substitute claims, with the unpatentability of the original claims not in dispute. As such and assuming the Board agrees, Petitioner requests oral argument on at least the following issues related to the patentability of proposed substitute claims:

- Any issue addressed in Petitioner's Opposition to Revised Motion to Amend; and
- Rebuttal to Patent Owner's presentation on all issues, including the issues listed above and any issues raised in the Motion to Amend or elsewhere in the record for this proceeding.

The Board previously scheduled Oral Hearing for this case on December 7, 2020. Petitioner believes the parties need only 60 minutes per side to present arguments in this proceeding and related proceedings IPR2019-00858, -00859,

-00860, -00861, -00863. Petitioner believes that 60 minutes should be sufficient to address issues related to the Revised Motion to Amend and should allow some time for Petitioner to address patentability of the original claims. But to the extent the Board wants Petitioner to more fully address the original claims, Petitioner requests an additional 30 minutes across all of these proceedings for a total of 90 minutes per side.
