**PETITIONERS' REQUEST FOR REFUND OF POST-INSTITUTION FEES**

Case No. IPR2025-00361

Petitioners' Request for Refund of Post-Institution Fees

AT&T Services Inc., Cellco Partnership D/B/A Verizon Wireless, and Nokia of America Corporation, (collectively, "Petitioners") request a refund of post-institution fees in the amount of \$28,125.

On February 7, 2025, Petitioners filed a Petition for Inter Partes Review of U.S. Patent No. 11,856,132. As required by 37 C.F.R. § 42.15(a), Petitioners deposited \$51,877 with the U.S. Patent and Trademark Office ("USPTO") at the time of filing the Petition to cover associated fees. Petitioners' payment consisted of \$23,750 in fees associated with the request for Inter Partes Review, and a further \$28,125 in post-institution fees.

On July 29, 2025, the Board issued an Order terminating this proceeding upon Denying Institution of this proceeding. Paper 12. In light of early stages of this proceeding and minimal resources expended pre-institution, Petitioner requests a refund of the post-institution fees paid to the USPTO in connection with this proceeding, totaling \$28,125, to be paid to deposit account No. 04-01679 (referencing Attorney Docket No. J2064-00001).
