ORDER
Granting Patent Owner's Motion for Withdrawal of Counsel
37 C.F.R. § 42.10

With authorization from the Board provided in an email dated August 29, 2025, Skyworks Solutions, Inc. (“Patent Owner”) filed an Unopposed Motion for Withdrawal of Counsel Joseph F. Haag. Paper 14 (“Motion”). The Motion requests authorization to withdraw Joseph Haag as counsel from this proceeding. *Id.* at 1. The Motion explains that “Counsel Joseph Haag is no longer affiliated with Wilmer Cutler Pickering Hale & Dorr LLP as of August 1, 2025.” *Id.* Patent Owner represents that Petitioner does not oppose the Motion. *Id.*

Patent Owner indicates that it will be represented by Haixia Lin (Reg. No. 61,318) as lead counsel and Danny S. Perry and Jungyeon Kim as back-up counsel in this proceeding. Motion 1; Paper 11, 3; *see* 37 C.F.R. § 42.10(a) (“If a party is represented by counsel, the party must designate a lead counsel and at least one back-up counsel.”). Patent Owner has filed Updated Mandatory Notices, which list a complement of counsel that does not include Mr. Haag. Paper 11, 3.

In consideration of the foregoing, it is hereby

ORDERED that Patent Owner’s Motion is *granted*, and Joseph F. Haag is allowed to withdraw as counsel from this proceeding; and

FURTHER ORDERED that the withdrawal of Mr. Haag will be effective upon filing in this proceeding of a Power of Attorney designating Haixia Lin as lead counsel.
