I. INTRODUCTION

Pursuant to 37 C.F.R. §§ 42.14 and 42.54, Patent Owner Halozyme, Inc. (“Halozyme”) respectfully submits this Motion to Seal the confidential version of Patent Owner’s Brief on Testimony of Ms. Kelly Grez (“Patent Owner’s Grez Testimony Brief”), according to the terms of the Default Protective Order entered into this proceeding by the Board.

All of the allegedly confidential material belongs to Petitioner Merck Sharp & Dohme LLC (“Petitioner”) or its parent company Merck & Co., Inc. (collectively, “Merck”). The parties have met and conferred and Petitioner does not oppose this Motion.

II. GOVERNING RULES AND PTAB GUIDANCE

In determining whether to grant a motion to seal, the Board must find “good cause,” 37 C.F.R. § 42.54(a), and “strike a balance between the public’s interest in maintaining a complete and understandable file history and the parties’ interest in protecting truly sensitive information,” Consolidated Trial Practice Guide, November 2019 (“TPG”), 19. The Board identifies confidential information in a manner “consistent with Federal Rule of Civil Procedure 26(c)(1)(G), which provides for protective orders for ... confidential research, development, or commercial information.” *Id.*

Based on the procedure set forth in the TPG, Halozyme seeks to prevent the

disclosure of information Petitioner has alleged is confidential.

III. IDENTIFICATION OF CONFIDENTIAL INFORMATION

Specifically, based on procedure provided in the TPG, Halozyme seeks to prevent the disclosure of information Petitioner has alleged is confidential contained in Patent Owner's Grez Testimony Brief.

A. Patent Owner's Grez Testimony Brief

Portions of Patent Owner's Grez Testimony Brief contain information that Petitioner has marked as "PROTECTIVE ORDER MATERIAL." Based on Petitioner's representation that the information contained therein is indeed confidential, the information sought to be sealed has not been published or otherwise made public.

IV. GOOD CAUSE EXISTS FOR GRANTING HALOZYME'S MOTION TO SEAL

Petitioner has represented that public disclosure of information contained in Patent Owner's Grez Testimony Brief would significantly harm Petitioner.

The public interest will not be harmed by granting this Motion to Seal. To the contrary, at least according to Petitioner's representations regarding the confidentiality of the underlying information, granting this Motion to Seal would achieve "a balance between the public's interest in maintaining a complete and understandable file history and the parties' interest in protecting truly sensitive information." 77 Fed. Reg. 48,755, 48,760 (Aug. 14, 2012). Therefore, good cause

exists for granting this Motion to Seal.

V. CONCLUSION

For the foregoing reasons, Patent Owner respectfully requests that the Board seal the confidential version of Patent Owner's Brief on Testimony of Ms. Kelly Grez.
