Thank you for calling me last night to discuss the complaint in the above-referenced matter. As I informed you Merck Sharp & Dohme Corp. does not exist. In the Spring of 2022 Merck Sharp & Dohme Corp. merged with and into Merck Sharp & Dohme LLC. Merck Sharp & Dohme LLC is the only surviving entity stemming from that merger. Therefore, the complaint was filed against the wrong entity. Likewise, service was ineffective.

Recognizing that, we think the simplest path forward is a substitution of the correct entity, Merck Sharp & Dohme LLC, for the incorrect entity, Merck Sharp & Dohme Corp. To accomplish that, we have prepared the attached stipulation that also addresses service and the time Merck Sharp & Dohme LLC has to respond to the complaint. At your convenience would you kindly let us know if Halozyyme agrees to proceed with the stipulation. I look forward to your response.
