GRANT AND INTER PARTES REVIEW**

Respondents RingConn LLC, Shenzhen Ninenovo Technology Ltd., Ultrahuman Healthcare Pvt. Ltd., Ultrahuman Healthcare SP LLC, and Ultrahuman Healthcare Ltd. (collectively, "Respondents") respectfully submit this notice of supplemental authority regarding Respondents' Pre-Hearing Brief (EDIS Doc. ID 837040) in the above-captioned Investigation. On December 6, 2024, the U.S. Patent Trial and Appeal Board ("PTAB") issued institution decisions in PGR2024-00030 and IPR2024-00928, which relate to U.S. Patent Nos. 11,868,178 ("178 Patent") and 9,582,034 ("034 Patent") respectively. The '178 Patent is currently asserted in this Investigation and the '034 Patent is the original parent of the '178 Patent family.

In both decisions, the PTAB granted institution of post-grant review and inter partes review, respectively, based on certain grounds presented by Respondents. The PTAB's decisions are attached hereto as Exhibits 1-2 and are relevant to the parties' invalidity arguments as raised in Respondents' Pre-Hearing Brief.
