As I previously stated, in the event this matter proceeds to litigation, the burden will be upon Samsung to provide affirmative evidence to demonstrate that it has a license defense to the asserted patents. You have not yet provided that evidence. Despite that, we have provided Samsung a way for Four Batons to show you some of the evidence that it has which undermines Samsung's proposed license defense. There is no interest at this time in setting up a call with Four Batons, Samsung, Toshiba and Ericsson to discuss this matter. The applicable documents will speak for themselves, and you are otherwise free to contact those parties on your own. If you would like to discuss the prospect of negotiating a license, please let me know. Otherwise, I will assume these conversations have reached an impasse.

Dear Bongjune:

If this matter proceeds to litigation, the burden will be upon Samsung to prove that it has a license defense. Accordingly, the burden will be upon Samsung to produce evidence that it has a license to the asserted patents.

The burden will not be upon Four Batons to prove that Samsung is not licensed. Therefore, there is nothing unusual about Four Batons asking Samsung to provide evidence that it has a license defense given that Samsung has raised the defense and Samsung will have the burden of proving that defense at trial.

I have repeatedly offered to review redacted versions of the purported agreements that you claim show that Samsung is allegedly licensed to the asserted patents. You have not produced those agreements. Rather, you have claimed that the agreements are confidential. Yet, you have also apparently not sought consent from either Toshiba/TARI or Ericsson/Telcordia to produce redacted versions of the agreements. Rather, you have simply reiterated that Samsung is allegedly licensed, but without providing any evidence to support that allegation, which is a fact that Samsung will have the burden to prove at trial.

By contrast, I have told you that I have received confirmation from both Toshiba and Ericsson that the patents currently identified within Four Batons' preliminary infringement claim charts are not licensed to Samsung. Since my first email to you dated August 1, 2022, I have made additional inquiries. Both Toshiba and Ericsson have once again confirmed that the patents currently identified within Four Batons' preliminary infringement claim charts are not licensed to Samsung, and Four Batons is free to assert those patents in litigation against Samsung.

In particular, the patents currently identified within Four Batons' preliminary infringement claim charts against Samsung were previously owned by TARI, and not by Toshiba. Toshiba has told me that you are misunderstanding the applicable agreement between Samsung and Toshiba, and in particular, Toshiba gave no license to Samsung regarding any TARI patents. The patents previously asserted by 2BCom were not previously owned by TARI, and therefore, your suggestion that Four Batons is acting in bad faith is false.

To further prove this point, Four Batons is prepared to provide Samsung with an abridged and redacted version of the patent-transfer agreement between Four Batons and TARI that shows that TARI has confirmed, in writing, that the patents identified in Four Batons' preliminary infringement claim charts against Samsung are not currently licensed to Samsung. This will be written evidence that directly undermines your contention that Samsung is licensed to the patents by Toshiba. To share this document, we will require entering an NDA. Four Batons will not, however, sign any NDA that forces it to waive rights with respect to a future litigation.

Attached is a draft NDA. If you are willing to sign it, then I will send you the redacted/abridged agreement. Otherwise, we will potentially be at an impasse, and this matter will potentially advance to litigation where the burden will be upon Samsung to prove that it has a pre-existing license to the asserted patents.

Dear Zach,

It's frustrating that you simply reiterates Samsung products aren't licensed without providing supporting evidence.

You made similar allegation to us with Toshiba patents in 2BCOM case, as attached.

According to the attached email, you recognized that Samsung at least has the license of Toshiba patents for mobile products, and then sent different claim charts for Samsung non-mobile products such as TV.

Shortly thereafter, you signed a license with RPX all of sudden.

You sent us claim charts against Samsung mobile phone again with Toshiba patents, and I believe that's not a good-faith approach.

Again, I'm reiterating that Samsung has full license for all Samsung products with respect to Ericsson patents (including sold ones).

Frankly, it's unusual and confusing for a patent buyer to ask potential licensees to confirm whether they hold license right for the purchased patents.

If you think conversation with Ericsson and Toshiba would help resolve the issues, I'm open to join the discussion.

We have again checked with Toshiba, which has again confirmed that Samsung is not licensed to the particular patents within Four Batons Wireless' portfolio. We believe you may be misconstruing the applicable license agreements. We have also checked Ericsson, who has also confirmed that it does not believe that Samsung is licensed to the particular patents within Four Batons Wireless' portfolio. I reiterate our offer to review a redacted version of what you believe is the applicable agreement with Ericsson. Otherwise, our position remains that Samsung is not licensed to the patents within Four Batons Wireless' portfolio, and it cannot withdraw the claims at this time.

In the meantime, Four Batons has prepared three more claim charts against products sold by Samsung for the following patents: U.S. Patent Nos. 7,502,348; 7,768,982; and 8,073,436. Thank you for your email. We have already previously checked whether Samsung is licensed to the patents owned by Four Batons Wireless. We have checked with Toshiba, and we have checked with Ericsson. Based on those checks, our investigation shows that Samsung is not licensed, especially to U.S. Patent Nos. 8,239,671 and 8,798,006. Almost all of Four Batons patents—including U.S. Patent Nos. 8,239,671 and 8,798,006—were previously owned by TARI (Toshiba America Research, Inc.) and not by Toshiba Corp. To the extent that Toshiba and Samsung have a license, we understand that that license does not cover patents previously owned by TARI. In May 2021, Ericsson and Samsung publicly announced a global patent license agreement, but that was after Four Batons acquired its patent portfolio. Your email references an agreement between Samsung and Ericsson. If you believe this license covers any of Four Batons' patents, we are happy to review a (redacted, if necessary) copy of the license.

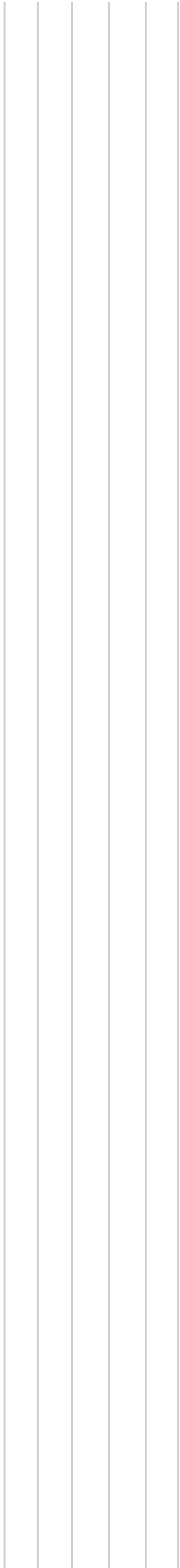

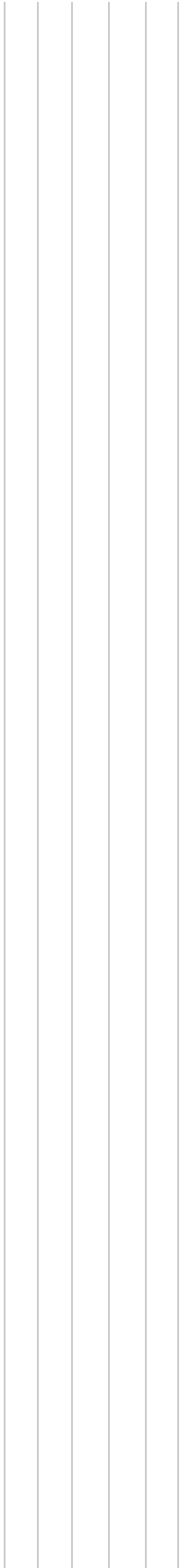

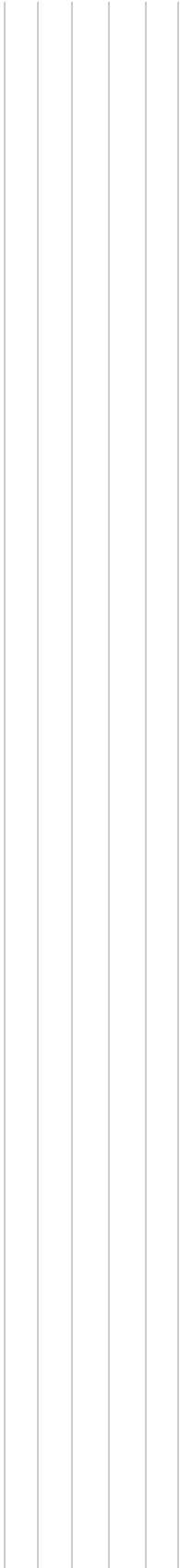
