**PLAINTIFF FOUR BATONS WIRELESS, LLC'S
DISCLOSURES PURSUANT TO LOCAL PATENT RULES 3-1 AND 3-2**

Pursuant to Local Patent Rules 3-1 and 3-2, Plaintiff Four Batons Wireless, LLC (“Four Batons”) provides its disclosure of asserted claims and preliminary infringement contentions and accompanying document production to Defendants Samsung Electronics Co., Ltd. (“Samsung Limited”) and Samsung Electronics America, Inc. (“Samsung America”) (“Samsung Limited” and “Samsung America” may be collectively referred to as “Samsung” or “Defendants”). Four Batons’s disclosures are based on publicly available materials regarding the accused infringing products of Defendants that describe or discuss aspects of operation of these products. Fact discovery and claim construction proceedings have not yet commenced. Four Batons has not had access to any discovery of Defendants’ materials at this point, and certain information is not yet available to Four Batons that may be relevant to its infringement claims. Four Batons reserves the right to supplement or alter its disclosures based on the discovery it obtains, invalidity and prior art contentions, claim construction, allowance and issuance of substitute claims by the USPTO, and/or any additional information provided by Defendants.
