**JOINT REQUEST TO MAINTAIN CONFIDENTIALITY  
UNDER 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74**

Samsung Electronics America, Inc. and Samsung Electronics Co., LTD (“Petitioners”) and Koninklijke KPN N.V. (“Patent Owner”) have executed a Settlement Agreement, filed contemporaneously herewith as EX1114, regarding U.S. Patent No. 8,660,560 (the “’560 Patent”). Under 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74, the parties jointly request that the Board treat the Settlement Agreement as business confidential information, keeping the Settlement Agreement separate from the file of the ’560 patent involved in this *inter partes* review, and make the Settlement Agreement available only to those required by law as specified in 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74(c).

In connection with their Joint Motion to Terminate, the parties have filed herewith a true and correct copy of the Settlement Agreement as required by 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74, via the PACTS system to provide availability to “Filing Party and Board” only. Pursuant to the Settlement Agreement, the parties must keep the terms of the Settlement Agreement confidential, and they represent that they have treated the terms accordingly and seek to continue treating them as confidential.
