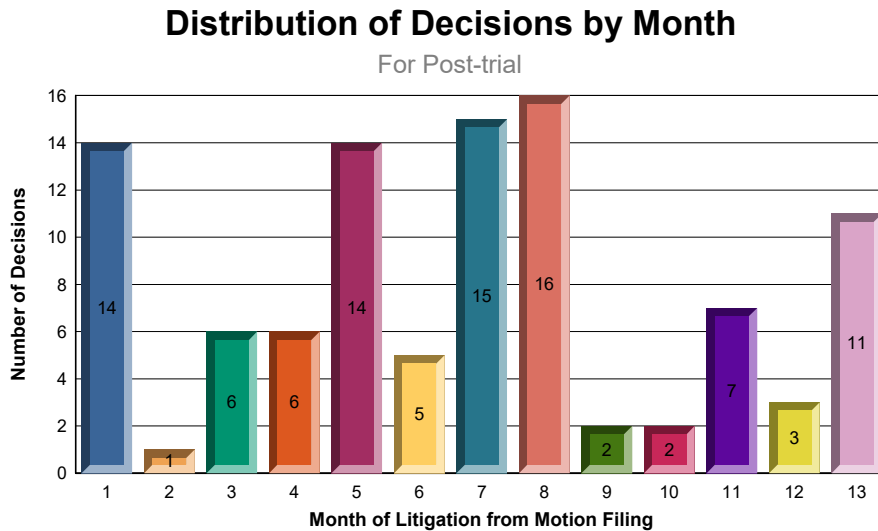

Post-trial

There were 102 Post-trial contested decisions by Judge Gilstrap. The overall contested win rate on these motions was 9.8%. The average time (in months) from motion filing to decision (or in the case of Markman rulings, from case filing to decision) was 6.9. The distribution of time to decision for the first 12 months of motion pendency is shown below, with any motions remaining pendency after 12 months lumped into month "13". Months with no decisions are not included in the chart. Note that the first month includes all decisions occurring less than 1 month from motion filing.



The supporting data is shown below. The table below identifies motion subjects ("What") and grounds ("Why") and includes the designation GIP for those subjects and grounds which were granted in part and denied in part.
