JOINT CLAIM CONSTRUCTION STATEMENT

Pursuant to this Court’s Scheduling Order (Dkt. 28) dated May 30, 2023, Plaintiff Mobile Data Technologies LLC (“Plaintiff” or “MDT”) and Defendant Meta Platforms, Inc. (“Defendants” or “Meta”), (together, Plaintiff and Defendant are referred to as the “Parties”) hereby respectfully submit this Joint Claim Construction Statement. The Joint Claim Construction Statement identifies agreed and disputed constructions for each of the claim terms at issue concerning U.S. Patent Nos. 8,739,336 (the “’336 Patent”), 8,825,801 (the “’801 Patent”), 9,032,039 (the “’039 Patent”), 9,619,578 (the “’578 Patent”), 9,922,348 (the “’348 Patent”), and 10,839,427 (the “’427 Patent”), (all together, the “Patents-in-Suit”).
