**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES**

On February 3, 2025, Petitioner Alliance Laundry Systems, LLC filed a Petition for Inter Partes Review No. IPR2025-00573 of U.S. Patent No. 11,481,772 (“the ’772 Patent”).
