On April 30, 2025, Petitioner NVIDIA Corporation filed its Petition for *inter partes* review (IPR) of U.S. Patent No. RE49,438 E (the '438 patent) along with the request fee of \$23,750.00, request fee for each claim in excess of 20 of \$13,160.00, the post-institution fee of \$28,125.00, and the post-institution fee for claim in excess of 20 of \$26,320.00. The Board, however, determined not to institute IPR with respect to the '438 patent. *See* Institution Decision, Paper 18 (September 12, 2025). Accordingly, Petitioners request a refund in the amount of \$54,445.00 for the post-institution fees. *See, e.g.,* 78 FR 4233 (Jan. 18, 2013), *available at* <http://www.gpo.gov/fdsys/pkg/FR-2013-01-18/pdf/2013-00819.pdf> (“The entire post-institution fee would be returned to the petitioner if the Office does not institute a review.”).
