Petitioner in IPR2025-00637 respectfully requests leave to file a short notice of supplemental authority concerning the Discretionary Denial Decisions of IPR2025-00785 and IPR2025-00786, issued on August 29, 2025—after Petitioner filed its Request for Director Review on August 26, 2025, in IPR2025-00637.
