PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES

Petitioner TankLogix, LLC (“Petitioner”) hereby files its request for a refund totally \$30,945, which includes the \$28,125 post-institution fee and the three \$940 (i.e., \$2,820 in total) post-institution request fees for each claim in excess of 20 that was previously paid in connection with IPR2025-00647. On February 28, 2025, Petitioner filed a petition for *Inter Partes* Review of U.S. Patent No. 9,898,014 and paid the USPTO a total of \$56,105 at the time of filing, which included the payment of an IPR request fee of \$23,750, three review request fees for claims in excess of 20 of \$1,410 (i.e., \$470 each), a \$28,125 payment for the post-institution fee, and three post-institution request fees for each claim in excess of 20 of \$2,820 (i.e., \$940 each) required under 37 C.F.R. § 42.15(a)(1)-(4). On July 31, 2025, the Director denied institution of the above captioned IPR.

Petitioner is entitled to request a refund of the post-institution fees that were previously paid and is entitled to this refund. *See* 78 Fed. Reg. 4233 (Jan. 18, 2013). (“The entire post-institution fee would be returned to the petitioner if the Office does not institute a review.”). Accordingly, Petitioner respectfully requests a refund of the \$30,945 associated with the post-institution fees it previously paid.

The post-institution fee was paid from Deposit Account No. DA603042, and the appropriate fees may be credited back to this Deposit Account.
