ORDER  
*Update to Scheduling Order*  
37 C.F.R. § 42.5

Trial was instituted in this proceeding on October 14, 2025, and a Scheduling Order was entered on October 17, 2025. *See* Papers 10 and 11.

The parties requested a conference call with the Board to address a dispute on whether a two-week extension of Due Dates for Patent Owner should be authorized. *See* Ex. 3001.

At a conference call held on December 2, 2025, Patent Owner asserted that good cause for an extension was based on the upcoming holidays and related travel, and deadlines in other district court matters. During the conference call, in response to the Board’s inquiry, Patent Owner certified that it would not file a motion to amend in this proceeding.

Petitioner asserted that sought extensions are unnecessary and lack good cause. Petitioner confirmed that the sought extensions would not prejudice Petitioner, but Petitioner maintained its opposition to the extensions.

We find that the balance between any burden on the parties and the Board, and good cause shown by Patent Owner weighs in favor of granting the requested extensions.
