EXAMINER'S AMENDMENT

Authorization for this examiner's amendment was given in a telephone interview with Gary R. Edwards (Reg. No.31,824) on May 24, 2007.

The application has been amended as follows: Claim 22, line 4 "squaring said input" is omitted and -squaring said **RF** input- is entered.

REASONS FOR ALLOWANCE

2. The following is an examiner's statement of reasons for allowance: Prior art discloses a system for reducing adjacent channel interference by pre-linearization and pre-distortion where a pre-distorting unit comprising an estimator derives the sum of squares of the magnitude of the real and imaginary parts of the input signal where a look-up table, which stores complex pre-distortion coefficients dependant upon the amplitude of the input signal as well as on the properties of the non-linear power amplifier the coefficients with the pre-distortion signal in the complex multiplier. The output is then up converted and applied to the amplifier. However, prior art fails to disclose a method for predistortion where a single RF input signal is copied and then phase shifted and processed to produce polynomial predistortion signals.
