DETAILED ACTION

Allowable Subject Matter

Claims 1-15 are allowed.

The following is an examiner's statement of reasons for allowance: prior art, U.S. Patents # 8351876, # 6731168, and # 7170345, does not teach nor render obvious an inner predistorter to predistort the first predistorted signal and generate a second predistorted signal, wherein the inner predistorter uses a second memory model that models power amplifier memory effects within a second range of time constants that is greater than the first range of time constants, and wherein the second predistorted signal is provided as an input to the power amplifier.
