**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES**

Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4212, 4232–4234 (Jan. 18, 2013), Petitioner, USAA Federal Savings Bank, requests a refund in the amount of \$28,125 to be credited to Deposit Account Number 06-1050.

On March 27, 2025, Petitioner filed a Petition for *Inter Partes* Review of U.S. Patent No. 11,070,530 with the Patent Trial and Appeal Board that was assigned case number IPR2025-00755.
