A. Real Party-In-Interest (37 C.F.R. §42.8(b)(1))

Amazon.com, Inc., Amazon.com Services LLC, Amazon Web Services, Inc., and Audible, Inc. are the real parties-in-interest.

B. Related Matters (37 C.F.R. §42.8(b)(2))

PO asserted the ’266 patent against Petitioners in patent infringement lawsuits captioned *Audio Pod IP, LLC v. Amazon.com, Inc. et al.*, No. 2:24-cv-00185 (E.D. Va., filed March 20, 2024) and *Audio Pod IP, LLC v. Amazon.com, Inc. et al.*, No. 3-24-cv-00407 (E.D. Va., filed May 30, 2024)¹. The portion of the -00185 case involving Audible was transferred to the District of New Jersey on April 1, 2025, as *Audio Pod IP, LLC v. Audible, Inc.*, No. 2-25-cv-02198 (D.N.J.). PO’s claims against Audible in the -00407 case were dismissed without prejudice. Audible also filed a complaint for declaratory judgment of noninfringement of the ’266 patent, captioned *Audible, Inc. v. Audio Pod IP, LLC*, No. 1:25-cv-02158 (S.D.N.Y., filed
