On January 16, 2026, pursuant to our authorization, Petitioner filed Motions to Withdraw Backup Counsel Han Saem (Sam) Hong (“Motions”) in the above-identified proceedings. Paper 20, 1.² Petitioner represents that Patent Owner does not oppose the Motions. *Id.*

Petitioner indicates that it will continue to be represented by lead counsel of record (Babak Tehranchi) and back-up counsel of record (including John C. Moulder, Noah Kim, and Yang-Hsien (Homer) Hsu). *See* Paper 21, 1. Petitioner also submitted an updated Power of Attorney identifying counsel of record. Paper 22, 1.

We have reviewed Petitioner’s Motions and determine that the withdrawal of Mr. Hong is warranted. Accordingly, Petitioner’s request to withdraw Mr. Hong in each proceeding is *granted*.

It is, therefore,

ORDERED that Petitioner’s Motions are *granted*, and Han Saem (Sam) Hong is withdrawn as counsel for Petitioner in the above-identified proceedings.
