The portion of this case involving Audible was transferred to the District of New Jersey on April 1, 2025, as *Audio Pod IP, LLC v. Audible, Inc.*, No. 2-25-cv-02198 (D.N.J.). Audible also filed a complaint for declaratory judgment of noninfringement of the ’740 patent, captioned *Audible, Inc. v. Audio Pod IP, LLC*, No. 1:25-cv-02158 (S.D.N.Y., filed March 14, 2025), which was dismissed on May 5, 2025.
