PETITIONER'S REQUEST FOR REFUND

Pursuant to the Patent and Trademark Office’s Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4211, 4233-34 (Jan. 18, 2013), Petitioner hereby requests a refund of the *Inter Partes* Review Post Institution Fee in the amount of \$28,125.00 to be paid to Petitioner’s Deposit Account.

On April 10, 2025, Petitioner filed a Petition for *Inter Partes* Review of claims 1-20 of U.S. Patent No. 10,877,233 with the Patent Trial and Appeal Board that was assigned case number IPR2025-00835. In accordance with the fee schedule specified in 37 C.F.R. § 42.15(a), Petitioner submitted payment in the amount of \$23,750.00 with the Board at the time of filing of its Petition to cover fees associated with Petitioner’s *Inter Partes* Review request, and a further \$28,125.00 in Post-Institution fees.

On August 19, 2025, Petitioner and Patent Owner Credo Technology Group Ltd. (collectively, “the parties”), filed a Joint Motion to Terminate Proceeding (Paper 10). On August 26, 2025, the Board entered a Decision Granting the Joint Motion to Terminate Proceeding and Order Dismissing the Petition Pursuant to Settlement Prior to Institution of Trial (Paper 12). Accordingly, Petitioner requests a refund of \$28,125.00 for the post-institution fees paid to the USPTO in connection with the instant proceeding. See 78 Fed. Reg. 4211, 4233-34 (“The Office also chooses to return fees for post institution services should a review not

be instituted The entire post-institution fee would be returned to the petitioner if the Office does not institute a review.”).
