**PETITIONER'S STIPULATION**

Pursuant to the Interim Processes for PTAB Workload Management, issued March 26, 2025,<sup>1</sup> the FAQs for Interim Processes for PTAB Workload Management,<sup>2</sup> and the Board’s guidance in the “Learn about the new interim processes relating to institution in AIA proceedings” presentation,<sup>3</sup> Petitioner, Toyota Motor Corp., stipulates as follows:

If the Patent Trial and Appeal Board (PTAB) institutes this *inter partes* review, Petitioner will not pursue against the ’034 Patent in *AutoConnect Holdings LLC v. Toyota Motor Corp. et al.*, No. 2:24-cv-00802 (E.D. Tex.) “the specific grounds [asserted in IPR2025-00890], or ... any other ground ... that was raised or could have been reasonably raised in an IPR (i.e., any ground that could be raised under §§ 102 or 103 on the basis of prior art patent or printed publications)” (*see Sotera Wireless, Inc. v. Masimo Corp.*, IPR2020-01019, Paper 12 at 13-14 (PTAB
