Pursuant to Order No. 9 (Revised Procedural Schedule), Complainant AX Wireless, LLC (“AXW” or “Complainant”) and Sony Interactive Entertainment, Inc., and Sony Interactive Entertainment, LLC (“Sony” or the “Sony Respondents”) submit that the parties attended an all-day, remote mediation session on August 7, 2025 before mediator Kent Stevens. The parties had productive discussions about the nature of their disputes and were able to reach an agreement in principle during the mediation. The parties are now working to reduce their agreement to a final settlement and intend to file a motion to terminate the investigation no later than August 22, 2025.
