The parties have met and conferred regarding narrowing the issues in dispute and, in reliance on certain disclosures from Defendants to Plaintiff have agreed to seek an order that:

- (1) Plaintiff’s claims asserted against Defendants in this action based on U.S. Patent No. 9,525,084 (the “’084 Patent”), including Count XI (Direct Infringement of the ’084 Patent) and Count XII (Indirect Infringement of the ’084 Patent) of the First Amended Complaint (Dkt. No. 52) are dismissed WITH PREJUDICE as to Defendants’ currently existing products and colorable variations thereof. All other claims of Plaintiff based on the ’084 patent are dismissed WITHOUT PREJUDICE;
