**SCHEDULING ORDER**

The Court hereby enters the following schedule to govern the above-captioned case:

Date	Deadline
3/28/25	<p>Plaintiff serves preliminary[1] infringement contentions in the form of a chart setting forth where in the accused product(s) each element of the asserted claim(s) are found. Plaintiff shall also identify the earliest priority date (i.e. the earliest date of invention) for each asserted claim and produce: (1) all documents evidencing conception and reduction to practice for each claimed invention, and (2) a copy of the file history for each patent in suit.</p> <p>[1] The parties may amend preliminary infringement contentions and preliminary invalidity contentions without leave of court so long as counsel certifies that it undertook reasonable efforts to prepare its preliminary contentions and the amendment is based on material identified after those preliminary contentions were served, and should do so seasonably upon identifying any such material. Any amendment to add patent claims requires leave of court so that the Court can address any scheduling issues.</p>
4/18/25	<p>The Parties shall <b>file a motion</b> to enter an agreed Scheduling Order. If the parties cannot agree, the parties shall submit a separate Joint Motion for entry of each Order briefly setting forth their respective positions on items where they cannot agree. Absent agreement of the parties, the Plaintiff shall be responsible for the timely submission of this and other Joint filings.</p>

4/25/25	Deadline to file a motion for transfer. After this deadline, movants must seek leave of Court and show good cause for the delay.
5/23/25	Defendant serves preliminary invalidity contentions in the form of (1) a chart setting forth where in the prior art references each element of the asserted claim(s) are found, (2) an identification of any limitations the Defendant contends are indefinite or lack written description under section 112, and (3) an identification of any claims the Defendant contends are directed to ineligible subject matter under section 101. Defendant shall also produce (1) all prior art referenced in the invalidity contentions, and (2) technical documents, including software where applicable, sufficient to show the operation of the accused product(s).
6/9/25	Parties exchange claim terms for construction.
6/23/25	Parties exchange proposed claim constructions.
6/30/25	Parties disclose extrinsic evidence. The parties shall disclose any extrinsic evidence, including the identity of any expert witness they may rely upon with respect to claim construction or indefiniteness. With respect to any expert identified, the parties shall identify the scope of the topics for the witness's expected testimony. With respect to items of extrinsic evidence, the parties shall identify each such item by production number or produce a copy of any such item if not previously produced.  Any party may utilize a rebuttal expert in response to a brief where expert testimony is relied upon by the other party.
7/7/25	Deadline to meet and confer to narrow terms in dispute and exchange revised list of terms/constructions.
7/21/25	Defendant files Opening claim construction brief, including any arguments that any claim terms are indefinite.
8/25/25	Plaintiff files Responsive claim construction brief.
9/8/25	Defendant files Reply claim construction brief.
9/8/25	Parties to jointly email the law clerks to confirm their Markman date. Parties to jointly email the Court's law clerk (see OGP at 1) if any venue or jurisdictional motions remain unripe for resolution.
9/22/25	Plaintiff files Sur-Reply claim construction brief.
9/25/25	Parties submit Joint Claim Construction Statement. See General Issues Note #9 regarding providing copies of the briefing to the Court and the technical adviser (if appointed).
9/29/25	Parties submit optional technical tutorials to the Court and technical adviser (if appointed).
10/6/25	<b>Markman Hearing</b>

10/7/25	Fact Discovery opens; deadline to serve Initial Disclosures per Rule 26(a).
11/7/25	Deadline to add parties.
12/1/25	Deadline to serve Final Infringement and Invalidity Contentions. After this date, leave of Court is required for any amendment to Infringement or Invalidity contentions. This deadline does not relieve the Parties of their obligation to amend if new information is identified after initial contentions.
1/26/26	Deadline to replead pre-suit willfulness or indirect infringement, if dismissed by stipulation without prejudice.
1/26/26	Deadline to amend pleadings. A motion is not required unless the amendment adds patents or patent claims. (Note: This includes amendments in response to a 12(c) motion.)
4/6/26	Deadline for the first of two meet and confers to discuss significantly narrowing the number of claims asserted and prior art references at issue. Unless the parties agree to the narrowing, they are ordered to contact the Court to arrange a teleconference with the Court to resolve the disputed issues.
5/4/26	Close of Fact Discovery
5/27/26	Opening Expert Reports
7/01/26	Rebuttal Expert Reports
7/22/26	Close of Expert Discovery
7/29/26	Deadline for the second of two meet and confer to discuss narrowing the number of claims asserted and prior art references at issue to triable limits. To the extent it helps the parties determine these limits, the parties are encouraged to contact the Court for an estimate of the amount of trial time anticipated per side. The parties shall <b>file a Joint Report within 5 business days</b> regarding the results of the meet and confer.
8/12/26	Dispositive motion deadline and Daubert motion deadline.  Deadline to file Form AO 85, "Notice, Consent, and Reference of A Civil Action to a Magistrate Judge," available at <a href="https://www.uscourts.gov/forms-rules/forms/notice-consent-and-reference-a-civil-action-a-magistrate-judge">https://www.uscourts.gov/forms-rules/forms/notice-consent-and-reference-a-civil-action-a-magistrate-judge</a> , if parties consent.
8/26/26	Serve Pretrial Disclosures (jury instructions, exhibits lists, witness lists, discovery and deposition designations).
9/9/26	Serve objections to pretrial disclosures/rebuttal disclosures.
9/16/26	Parties to contact Court to confirm their pretrial conference and trial dates.
9/23/26	Serve objections to rebuttal disclosures and <b>File</b> Motions <i>in-limine</i> .

9/30/26	File Joint Pretrial Order and Pretrial Submissions (jury instructions, exhibits lists, witness lists, discovery and deposition designations); file oppositions to motions <i>in limine</i> .
10/7/26	File Notice of Request for Daily Transcript or Real Time Reporting. If a daily transcript or real time reporting of court proceedings is requested for trial, the party or parties making said request shall file a notice with the Court and email the Court Reporter, Kristie Davis at <a href="mailto:kmdaviscsr@yahoo.com">kmdaviscsr@yahoo.com</a>  Deadline to file replies to motions <i>in limine</i> .
10/14/26	Deadline to meet and confer regarding remaining objections and disputes on motions in limine.
10/21/26	File joint notice identifying remaining objections to pretrial disclosures and disputes on motions <i>in limine</i> .
10/26/26	<b>Final Pretrial Conference.</b> Held in person.
11/16/26	<b>Jury Selection/Trial.</b>
