In support, Defendants represent that staying discovery would allow the parties to avoid costly discovery exchange. Plaintiff contests the Motion and argues that a stay would only serve to promote Defendants' delay. The Court notes that Defendants have not provided any reasoning for a stay beyond the normal costs and difficulties of litigation.
