Subject: Notice of infringement

Dear Mr. Prystawski,

I am writing to initiate a discussion regarding Geotab USA, Inc.'s ("Geotab") infringement of Fractus S.A.'s ("Fractus") patented technology.

Fractus is a Spanish company that is an early pioneer in the development of internal antennas for smartphones, tablets, and wireless Internet of Things devices. As a result of its work, Fractus owns a very large patent portfolio covering antennas and related technology for wireless communications. In part, the patents reflect Fractus's pioneering technology that allows wireless devices to have miniature and/or multiband internal antennas, the integration of multiple antennas within the wireless device, and their integration with sensing elements used in many wireless devices. Fractus has accrued significant public recognition and many awards for its remarkable antenna innovations.

Fractus's patents cover the technology that is ubiquitously employed by sellers, manufacturers, and users of wireless devices such as Geotab. Every wireless devices, including but not limited to aftermarket telematics devices and other solutions for fleets (i.e. cameras & ADAS, connected sensors, asset and trailer tracking), that (i) incorporate a multiband and/or miniaturized wireless antenna, or integrate multiple antennas, that comprise the features recited in any of the Fractus's patents, (ii) are made, used, imported, sold, or offered for sale, or otherwise exploited by Geotab in a jurisdiction covered by any such patent, and (iii) are purchased or manufactured by a licensee of Fractus and not covered by the license to that supplier, requires a license under those patents.

Fractus has analyzed some of Geotab's products and determined that Geotab, along with its subsidiaries, affiliates, suppliers, importers, distributors, dealers, and customers, infringe Fractus's patents. In particular, Exhibit I shows several examples of Geotab's products that infringe (both directly and indirectly) specific claims of patents owned by Fractus. In addition, we understand that Geotab regularly uses infringing

products in the ordinary course of its business, for example for fleet tracking and shipment monitoring applications. The specific device(s) used by Geotab for these purposes is(are) not publicly knowable, but may include other infringing wireless devices.

To be very clear, Exhibit I provides only examples. Fractus believes that similar products likely also infringe, such as older or newer models, or distinct models, using similar technology. Exhibit II to this letter provides a list of patents that are owned by Fractus and available for license to Geotab.

Fractus's proprietary technology is valuable to companies like Geotab and is a core component of their business. That value has been recognized with more than awards and public recognition. Fractus has already licensed its technology to wireless device manufacturers around the world, including Samsung, LG, HTC, ZTE, and many others, and to network infrastructure equipment manufacturers like CommScope and others.

Fractus has a strong preference for resolving intellectual property infringement by negotiation and invites Geotab to engage in meaningful discussions to determine where the companies' interests align.
