In compliance with my order, the parties submitted a joint status stating that they agreed that if the Arbitral Tribunal did not find the trade-secret misappropriation claims to be time-barred, it will also decide the merits of Evolutions trade-secret misappropriation claims. ECF No. [179]. As such, this matter remains stayed pending the outcome of arbitration. The parties must submit a second joint status report addressing arbitration either within seven days of the tribunal's decision or by November 30, 2026, whichever is earlier.
