**PETITIONER'S REQUEST FOR REFUND OF
POST-INSTITUTION FEES FOR *INTER PARTES* REVIEW**

On June 13, 2025, Baby Generation, Inc. Evenflo Company, Inc., and Monahan Products, LLC (collectively, "Petitioner") filed a Petition for *Inter Partes* Review of U.S. Patent No. 11,878,729. Paper 1 ("Petition"). On December 1, 2025, the Board issued a Decision denying *inter partes* review. Paper 17.
