**PATENT OWNER'S NOTICE OF DEPOSITION

Notice of Deposition

The deposition will be taken before a Notary Public or other officer authorized by law to administer oaths, and it will be recorded using stenographic means. Also take notice that the Court Reporter may also be remote via one of the

options above for the purposes of reporting the proceeding and will not be in the physical presence of the deponent. The deposition may also be video/audio recorded, a real-time transcript may be provided, and videoconference link may be provided for remote attendees of the deposition. Pursuant to 37 C.F.R.

§ 42.53(d)(1), the parties have conferred and have agreed on this date and location for Mr. Prairie's deposition.
