FIG. 10 is a side view thereof;

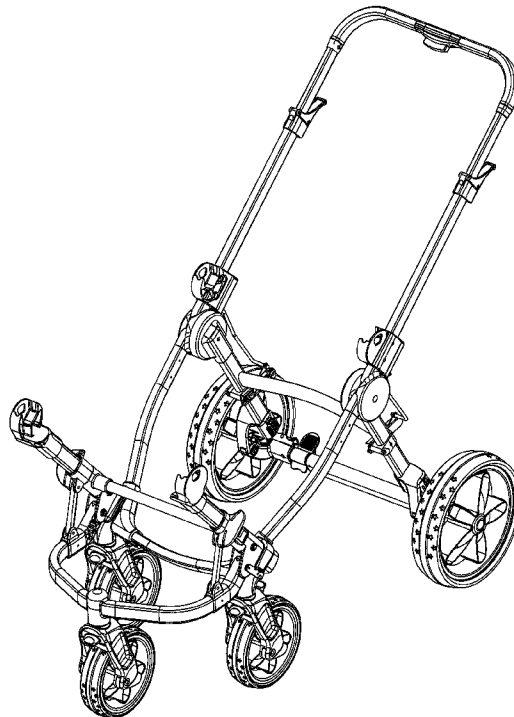
FIG. 11 is a side view thereof;

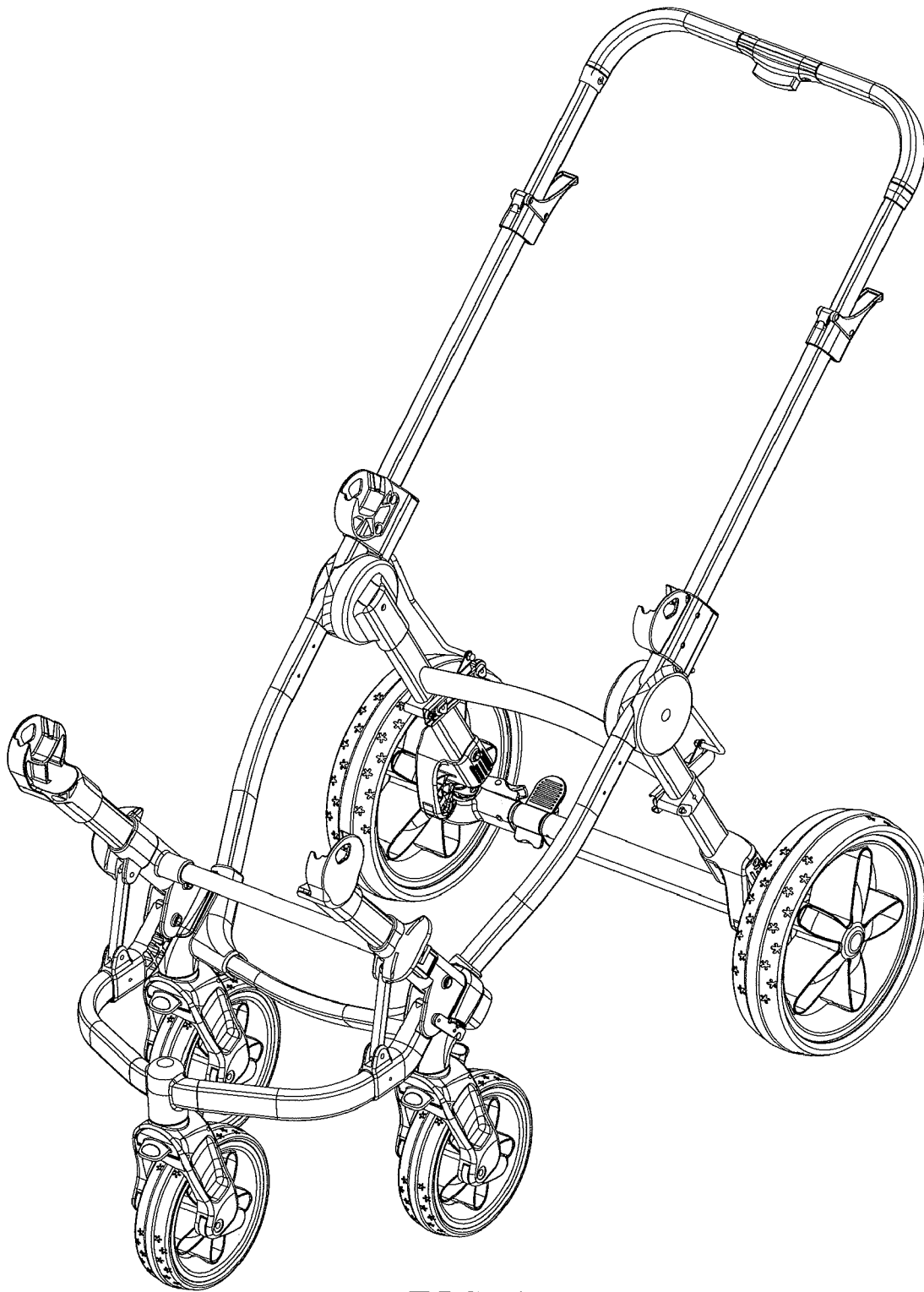

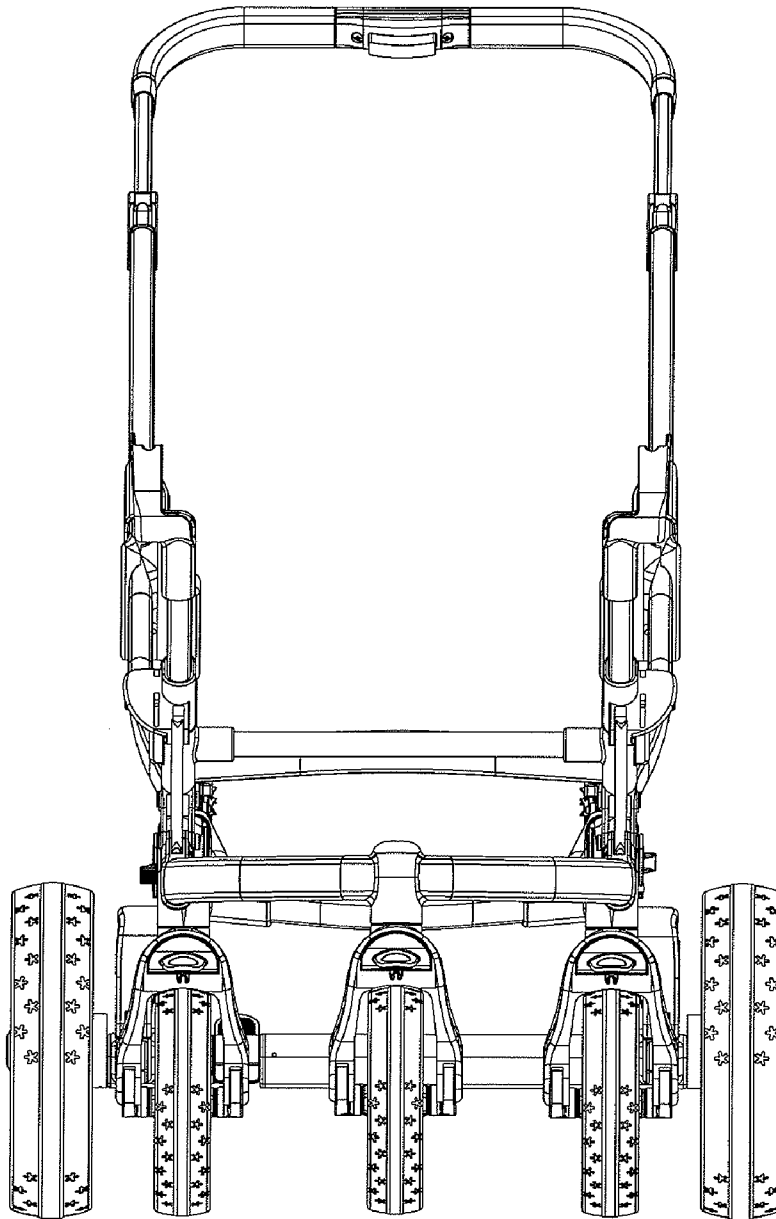

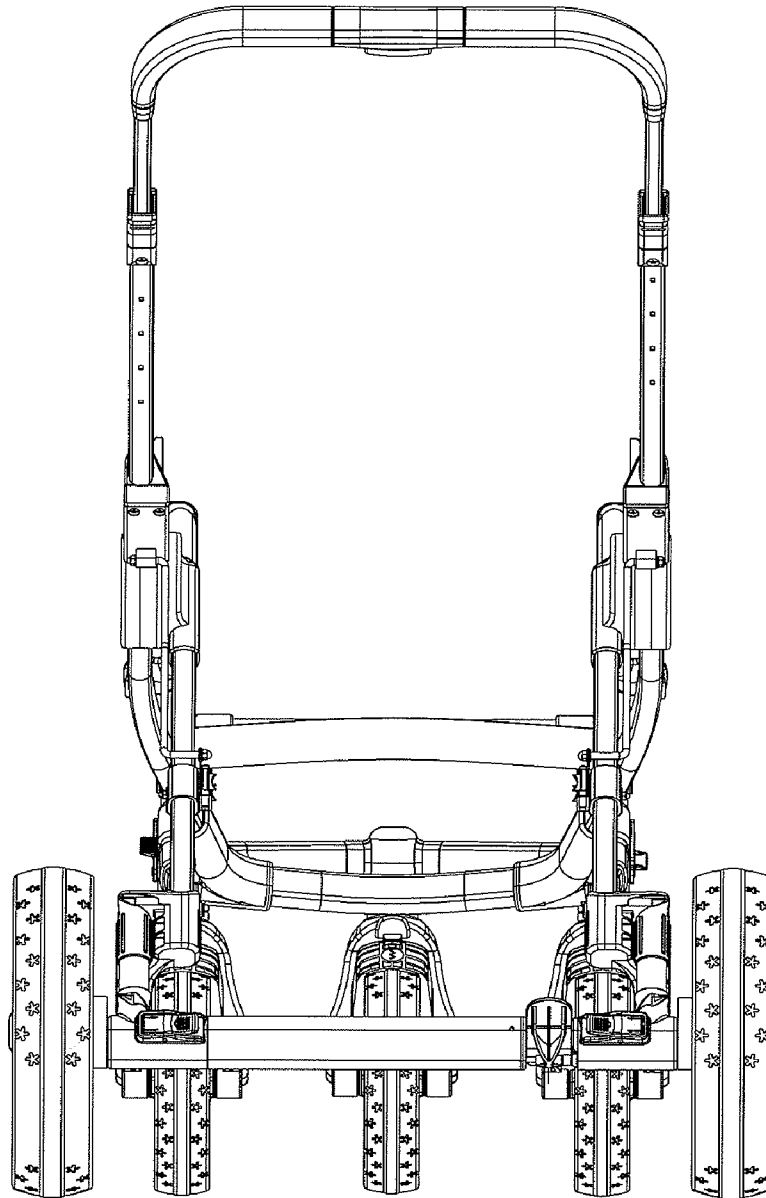

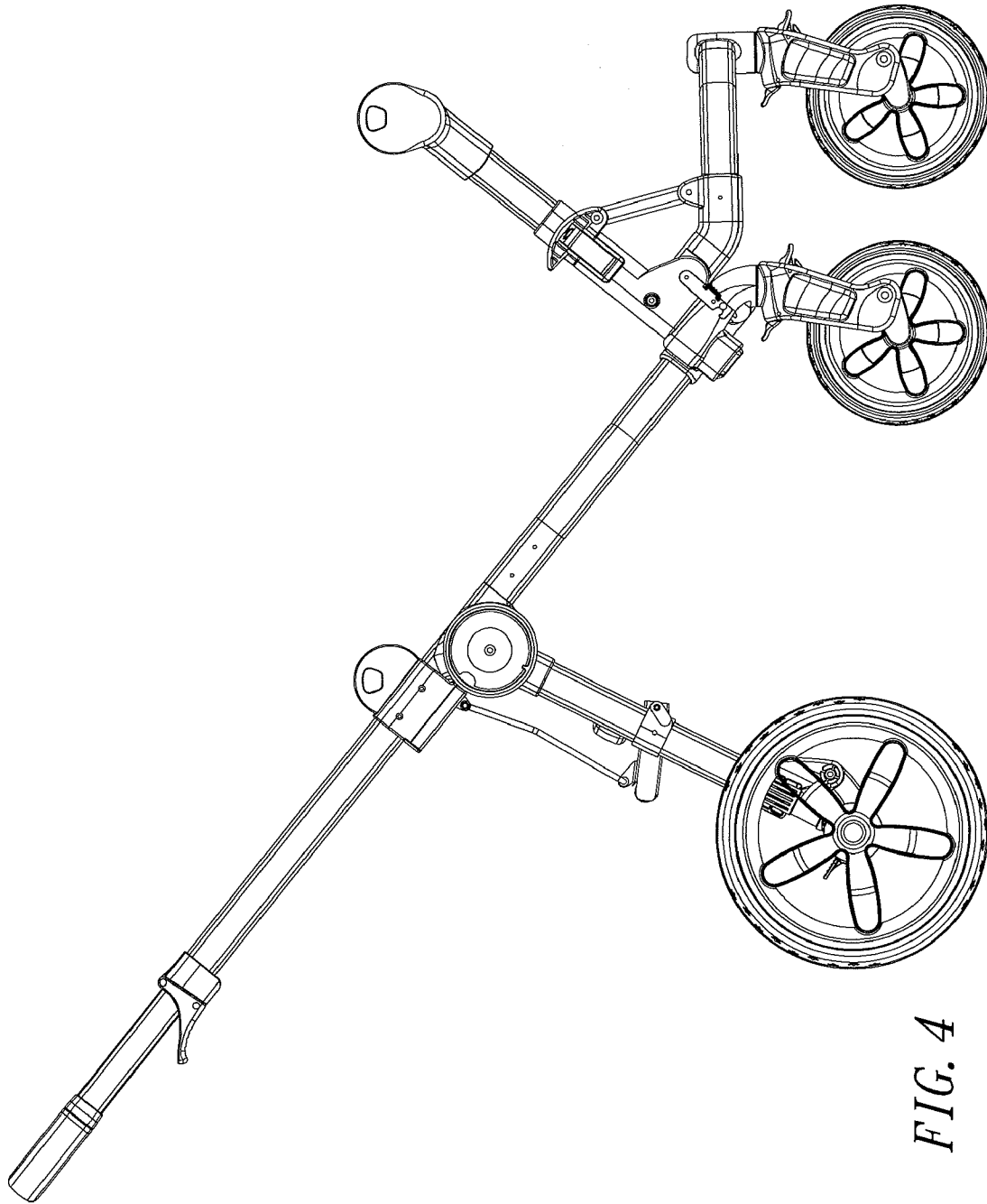

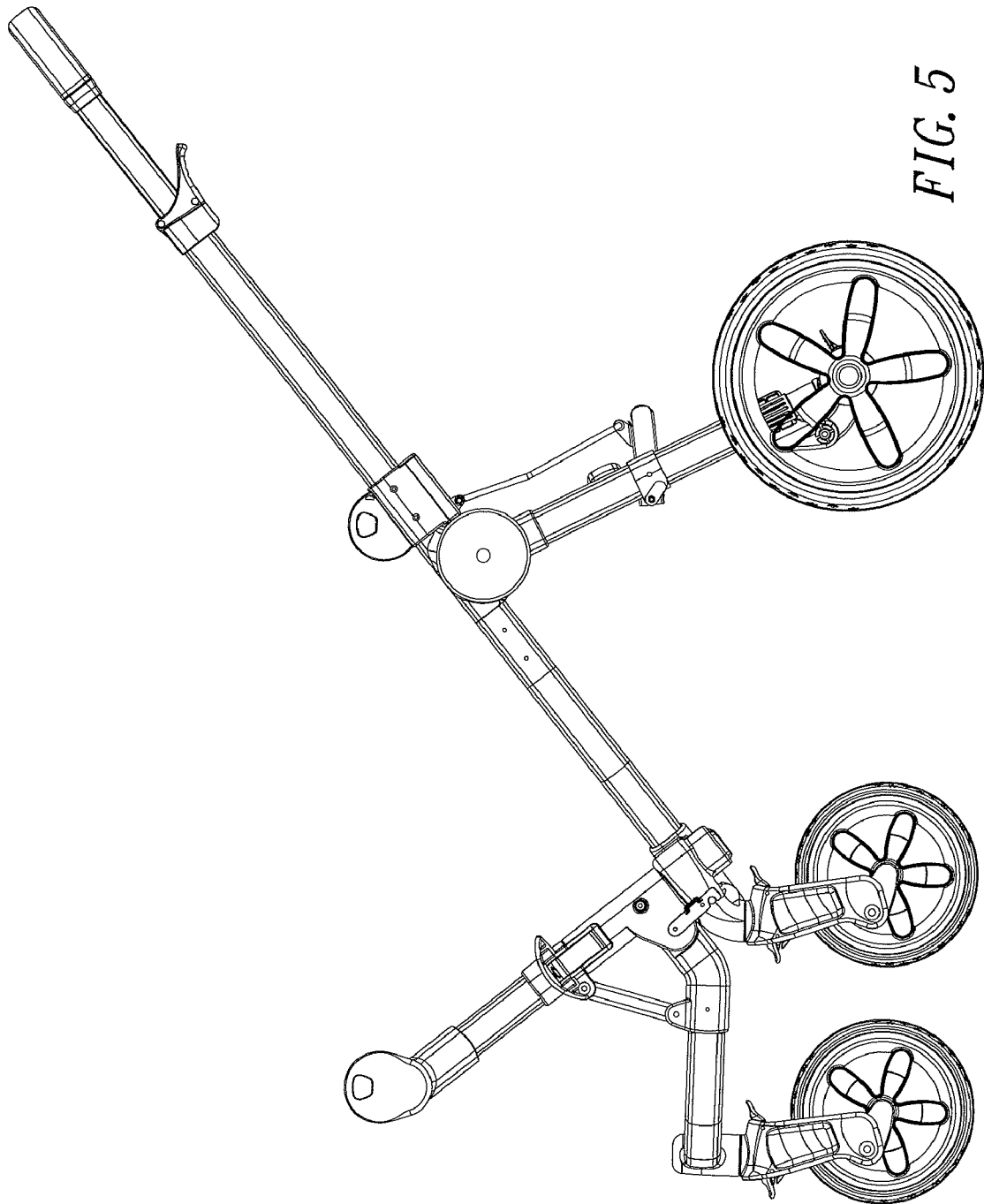

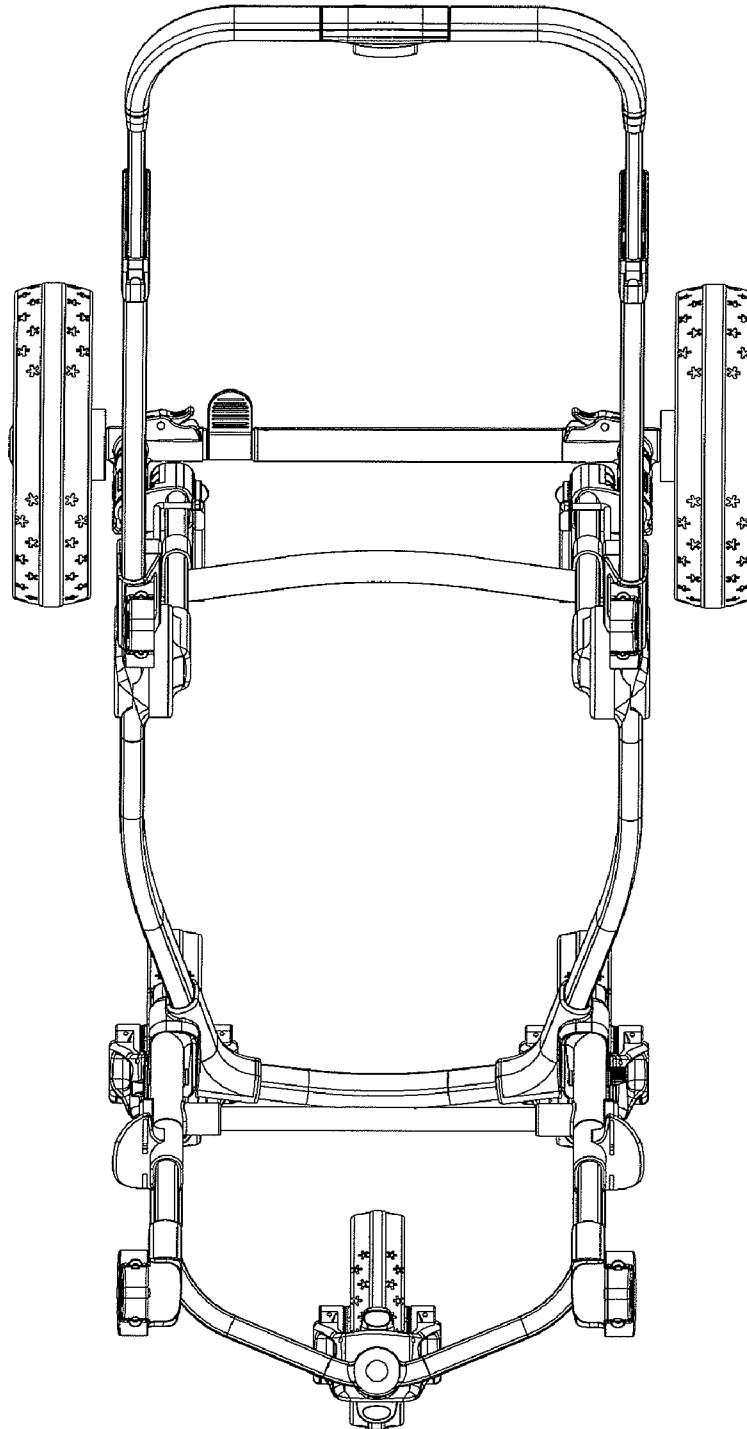

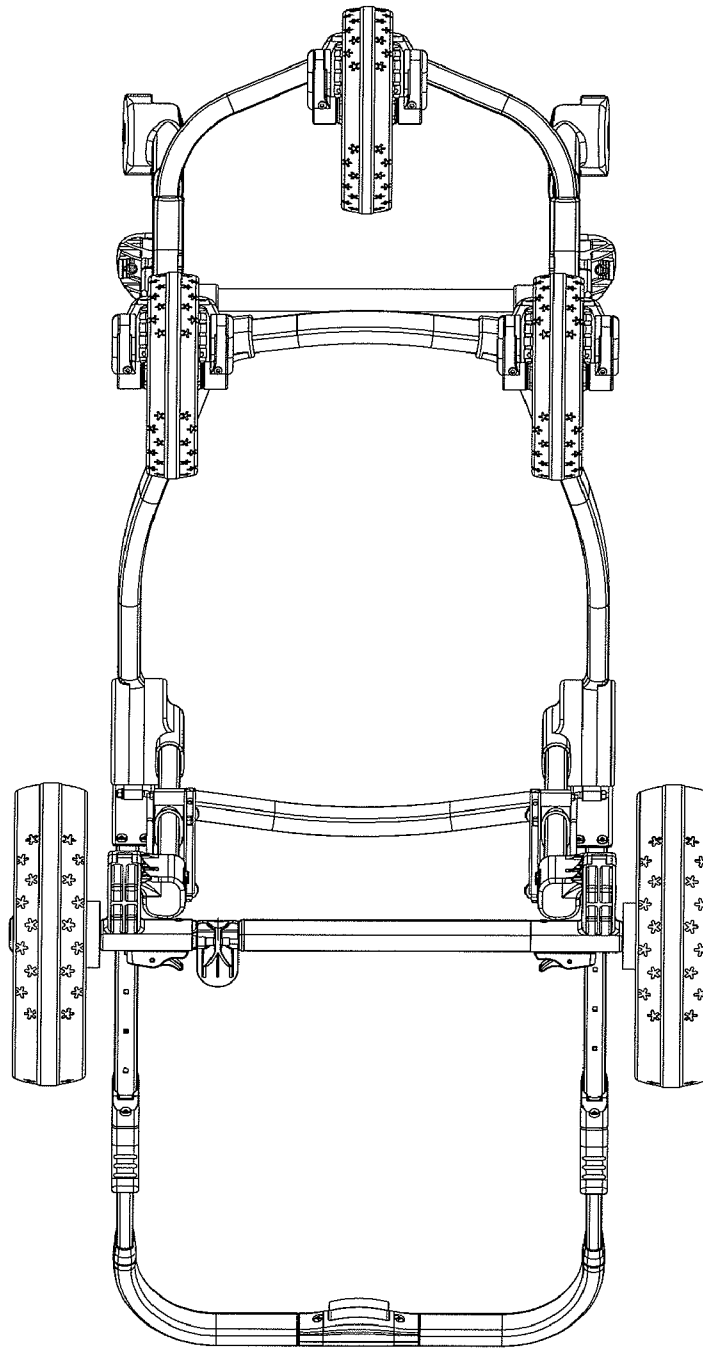
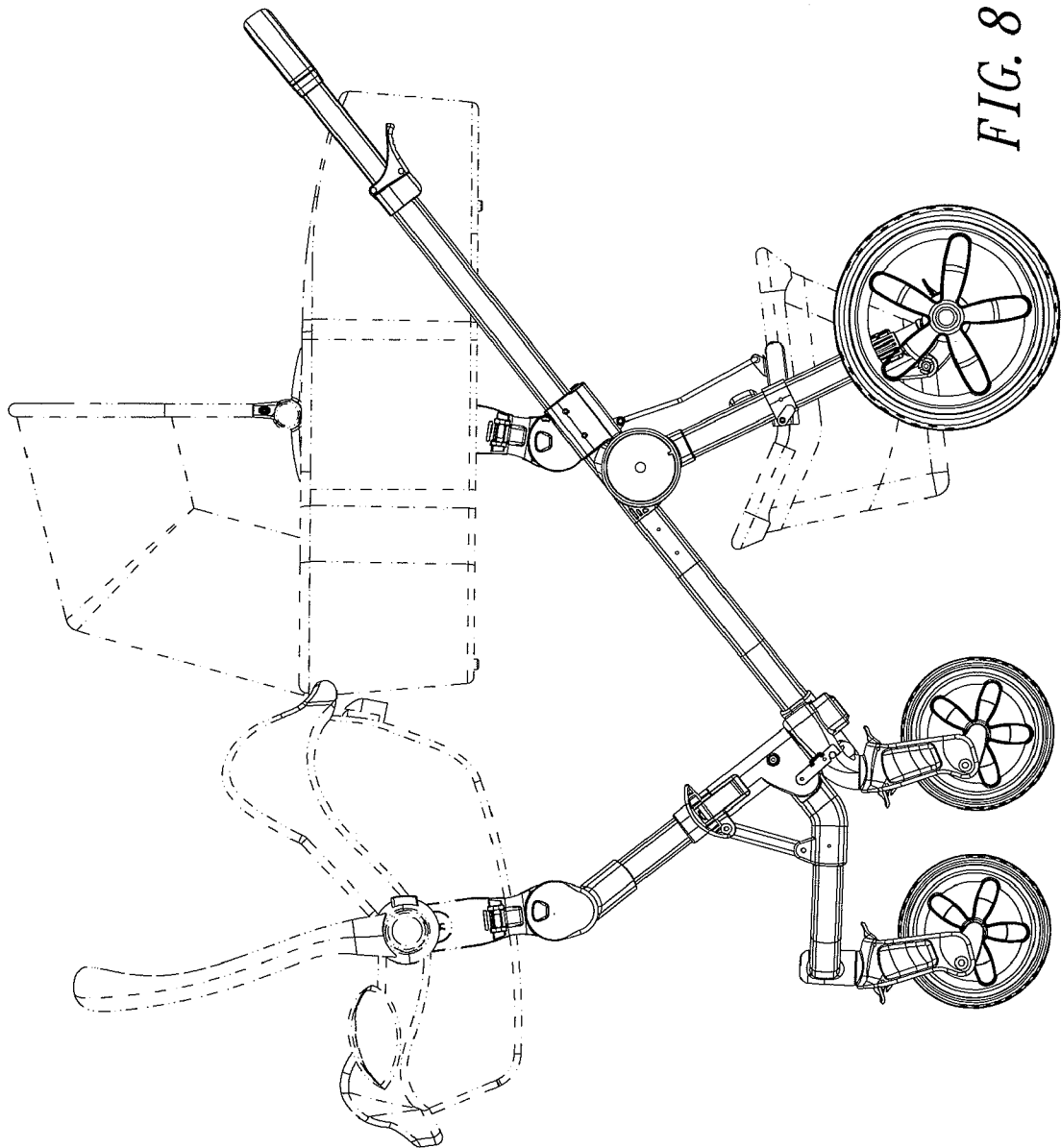

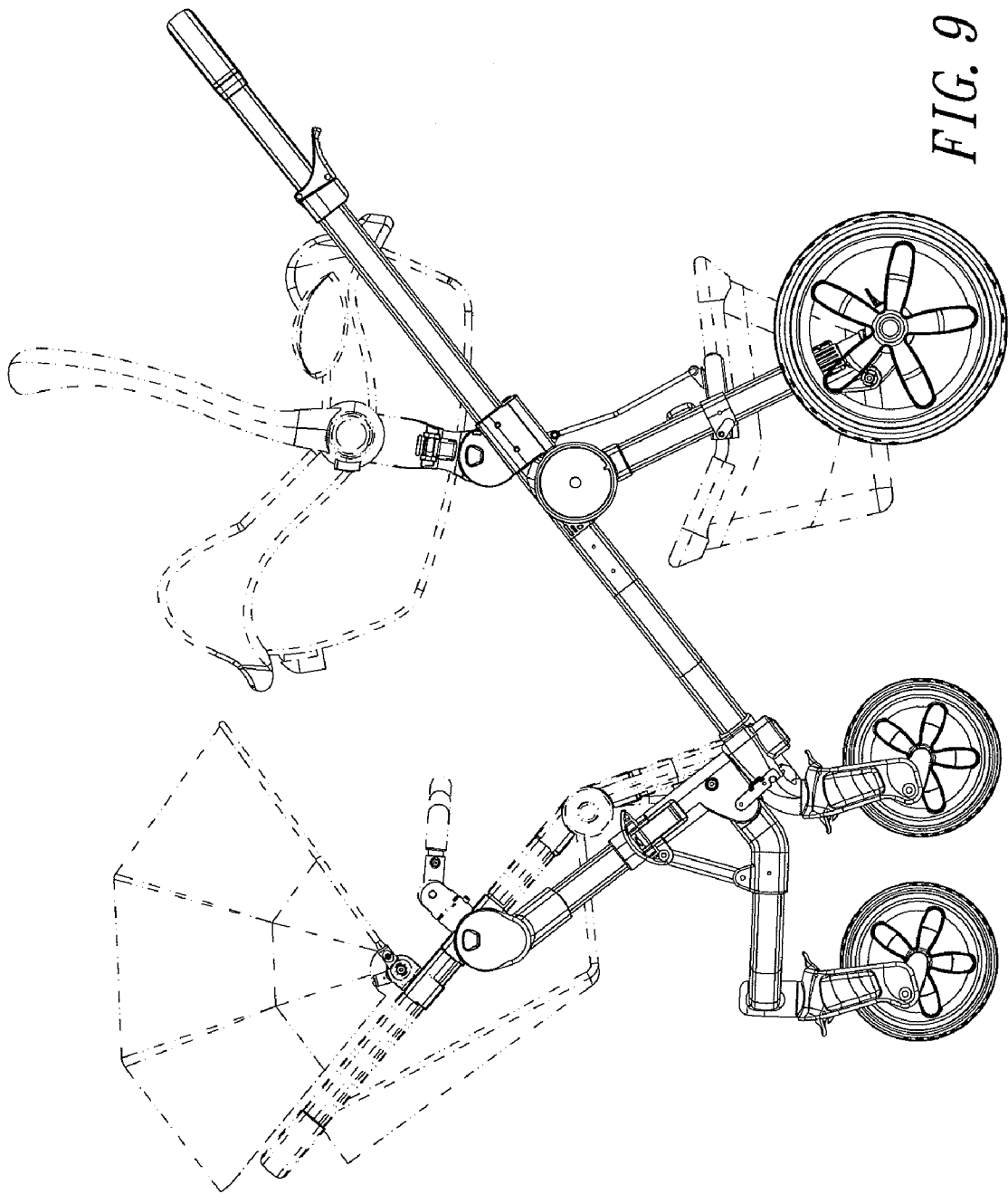
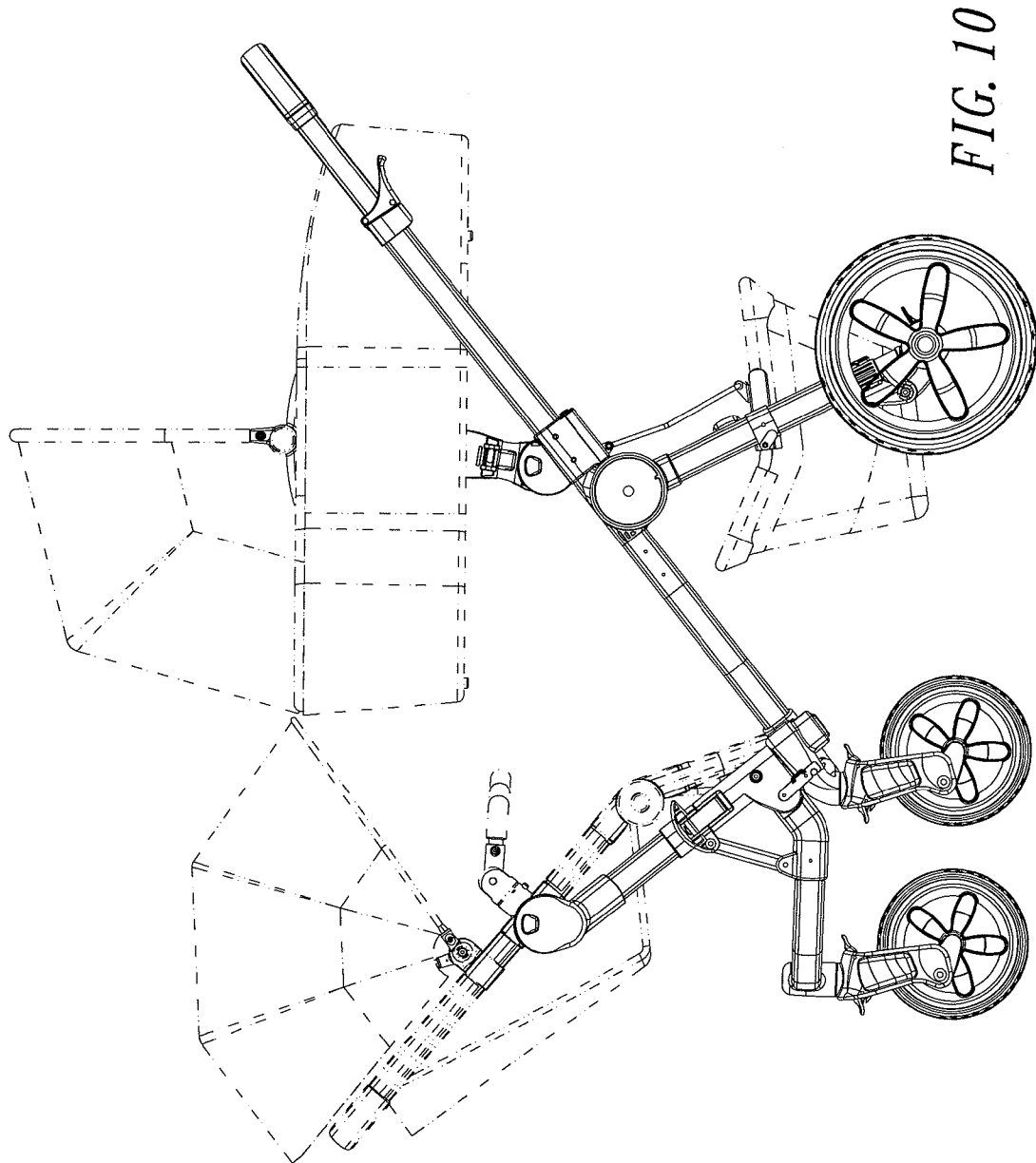

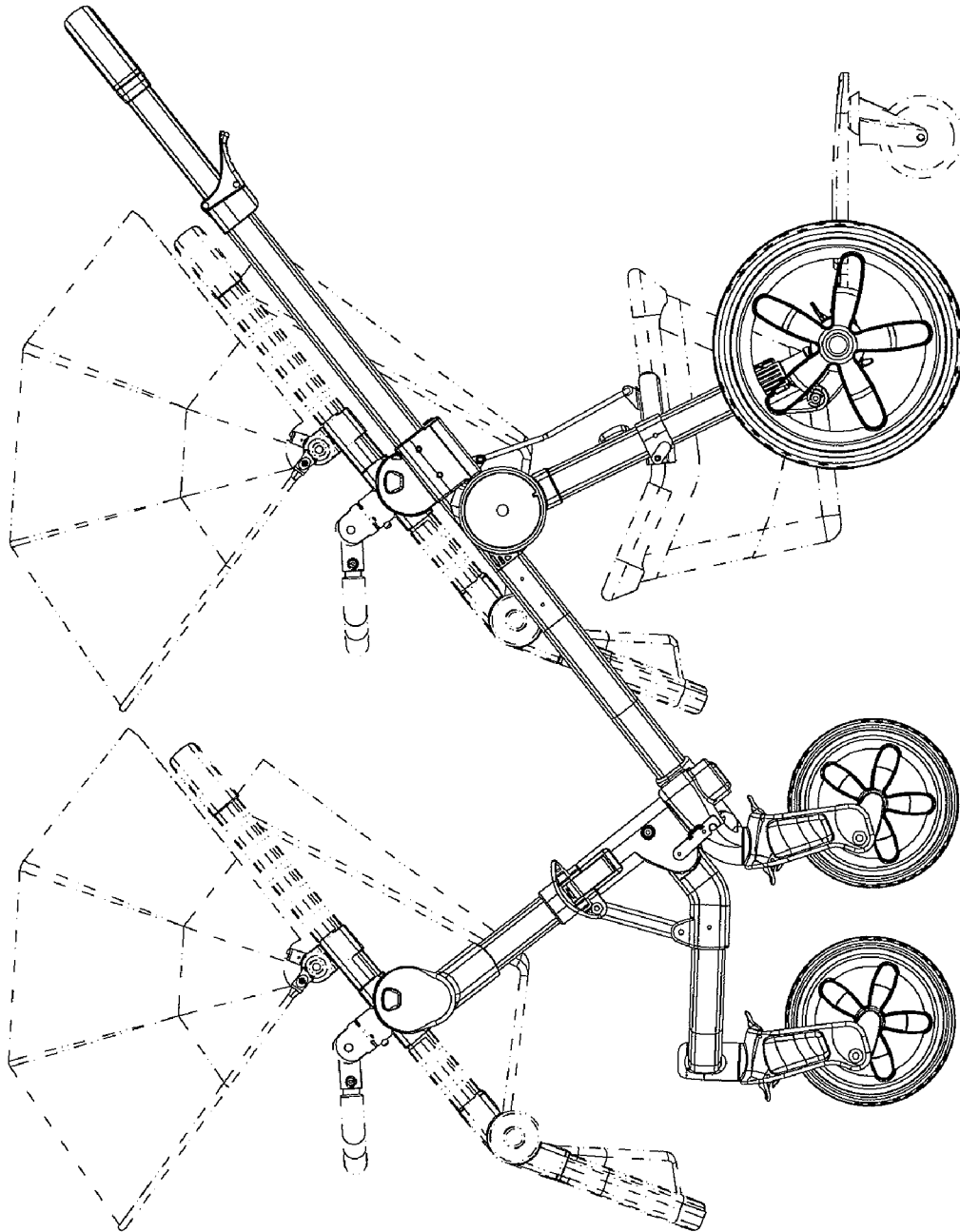

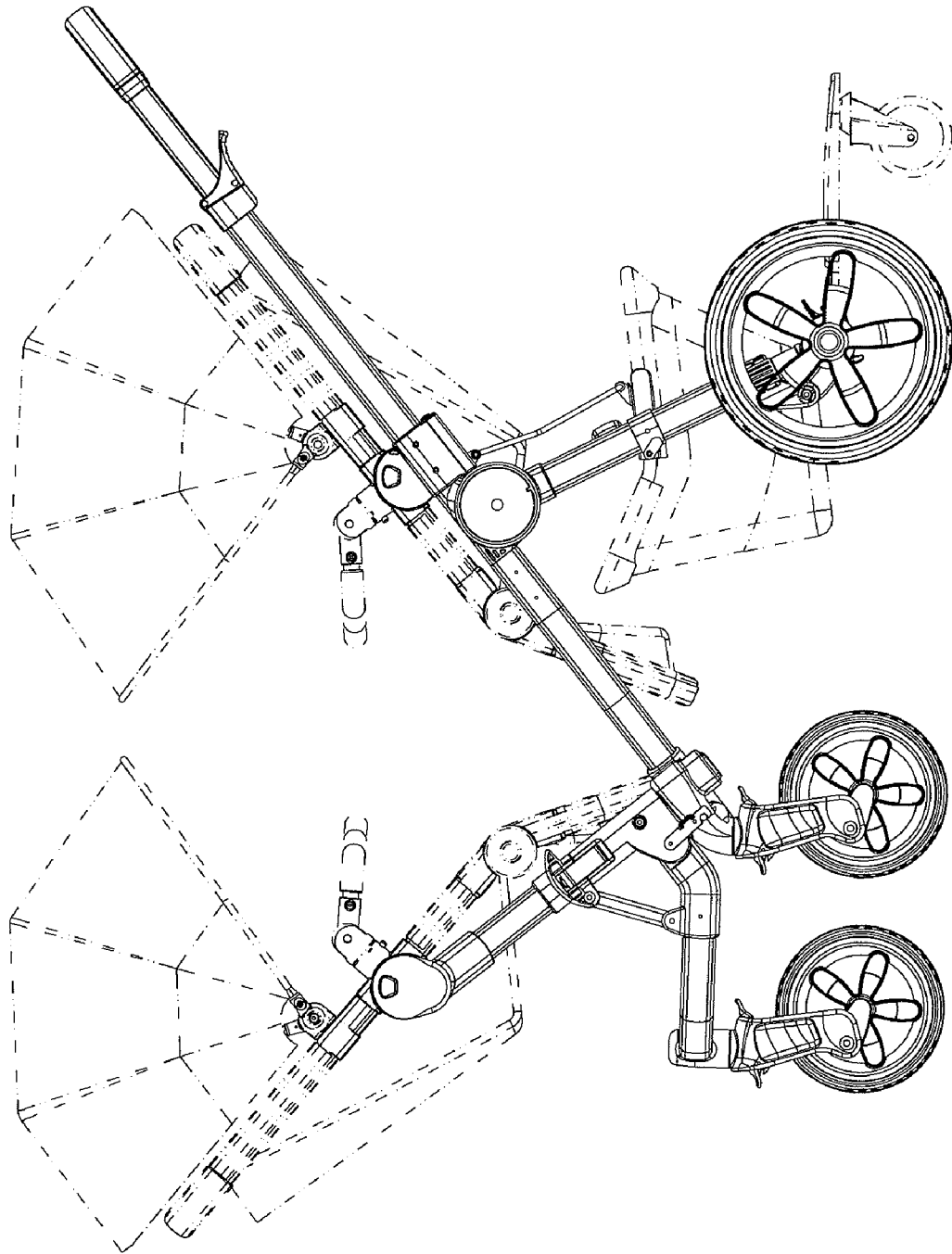

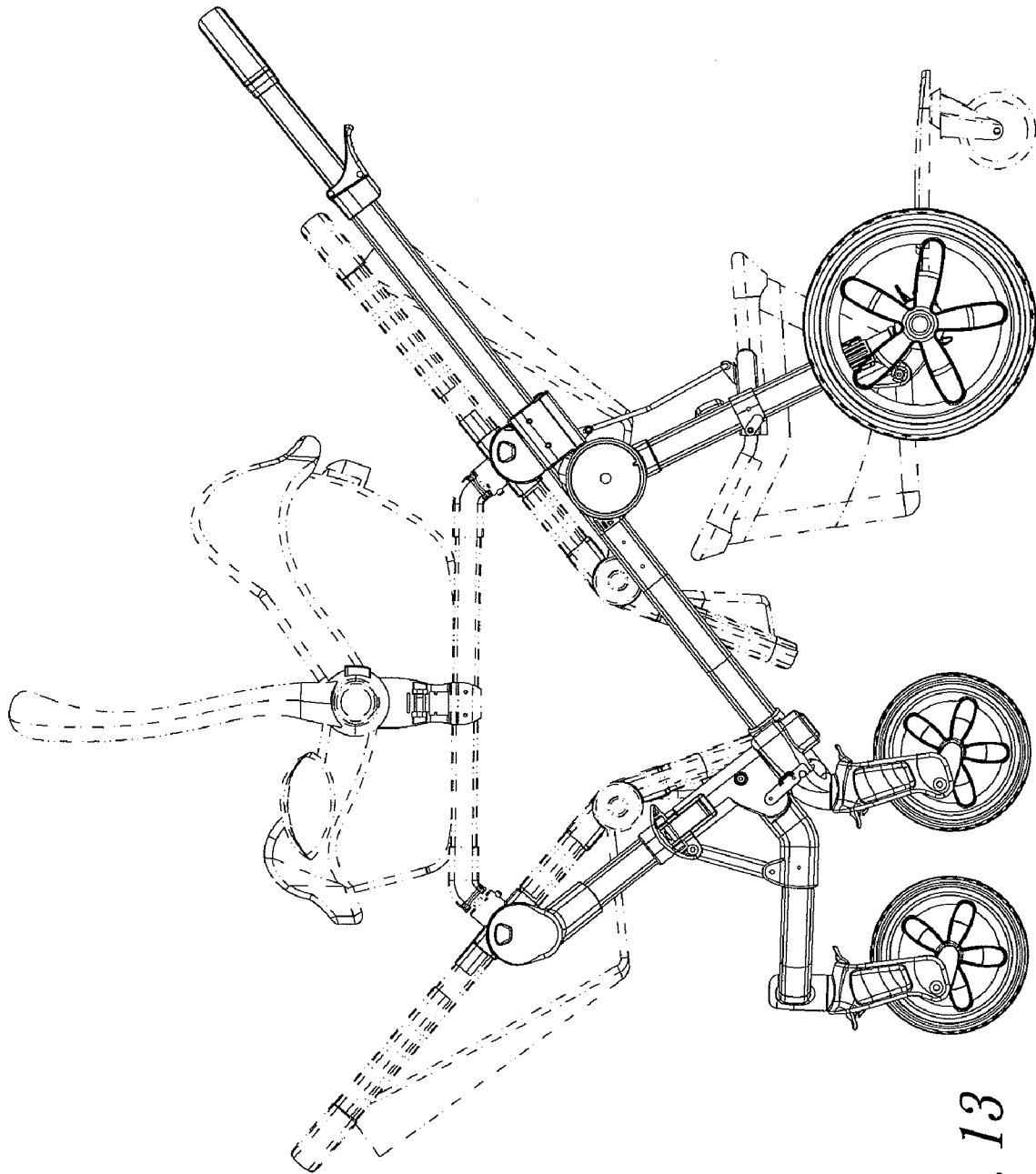
