ORDER  
Granting Petitioner’s Unopposed Motion to  
Withdraw and Substitute Counsel  
*37 C.F.R. § 42.10*

With the Board's prior authorization (*see* Ex. 3001), Topsoe, Inc. ("Petitioner") filed a Motion for Counsel to Withdraw. Paper 21 ("Mot.," "Motion"). Petitioner moves "to withdraw lead counsel Aaron R. Feigelson, and back-up counsels Stephen B. Barone and Sally A. Sullivan of Leydig, Voit & Mayer, Ltd." Mot. 2. Petitioner designates "Jeffrey A. Andrews (Reg. No. 62,206) of Yetter Coleman LLP as new lead counsel and Jeffrey J. Phillips (Reg. No. 51,125) of Spencer Fane LLP and Christopher R. Johnson (Reg. No. 64,720) of Yetter Coleman LLP as new back-up counsel." *Id.* Petitioner indicates "Counsel for Patent Owner has been notified and does not object to the withdrawal of current counsel, or to the substitution of new counsel." *Id.*

Petitioner filed an updated Mandatory Notice and a Power of Attorney listing Jeffrey A. Andrews as lead counsel, and Jeffrey J. Phillips and Christopher R. Johnson as back-up counsel. Papers 22, 23.

In view of the foregoing, Petitioner's Motion is *granted*.

It is

ORDERED that Petitioner's Motion to Withdraw and Substitute Counsel is *granted*;

FURTHER ORDERED that Aaron R. Feigelson shall be withdrawn as lead counsel for Petitioner, and Stephen B. Barone and Sally A. Sullivan shall be withdrawn as back-up counsel for Petitioner; and

FURTHER ORDERED that Jeffrey A. Andrews shall be substituted as lead counsel for Petitioner, and Jeffrey J. Phillips and Christopher R. Johnson shall be substituted as back-up counsel for Petitioner.
