(57) **CLAIM**

The ornamental design for a photography studio lighting kit, as shown and described.

DESCRIPTION

FIG. 1 is a top, back and right side perspective view of a photography studio lighting kit showing our new design; FIG. 2 is a bottom, front and left side perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a back elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is an enlarged view of portion 9 shown in FIG. 1;

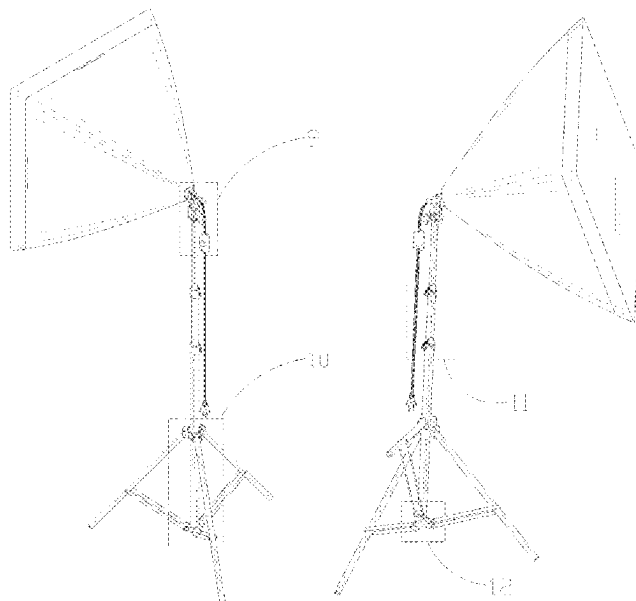
FIG. 10 is an enlarged view of portion 10 shown in FIG. 1;

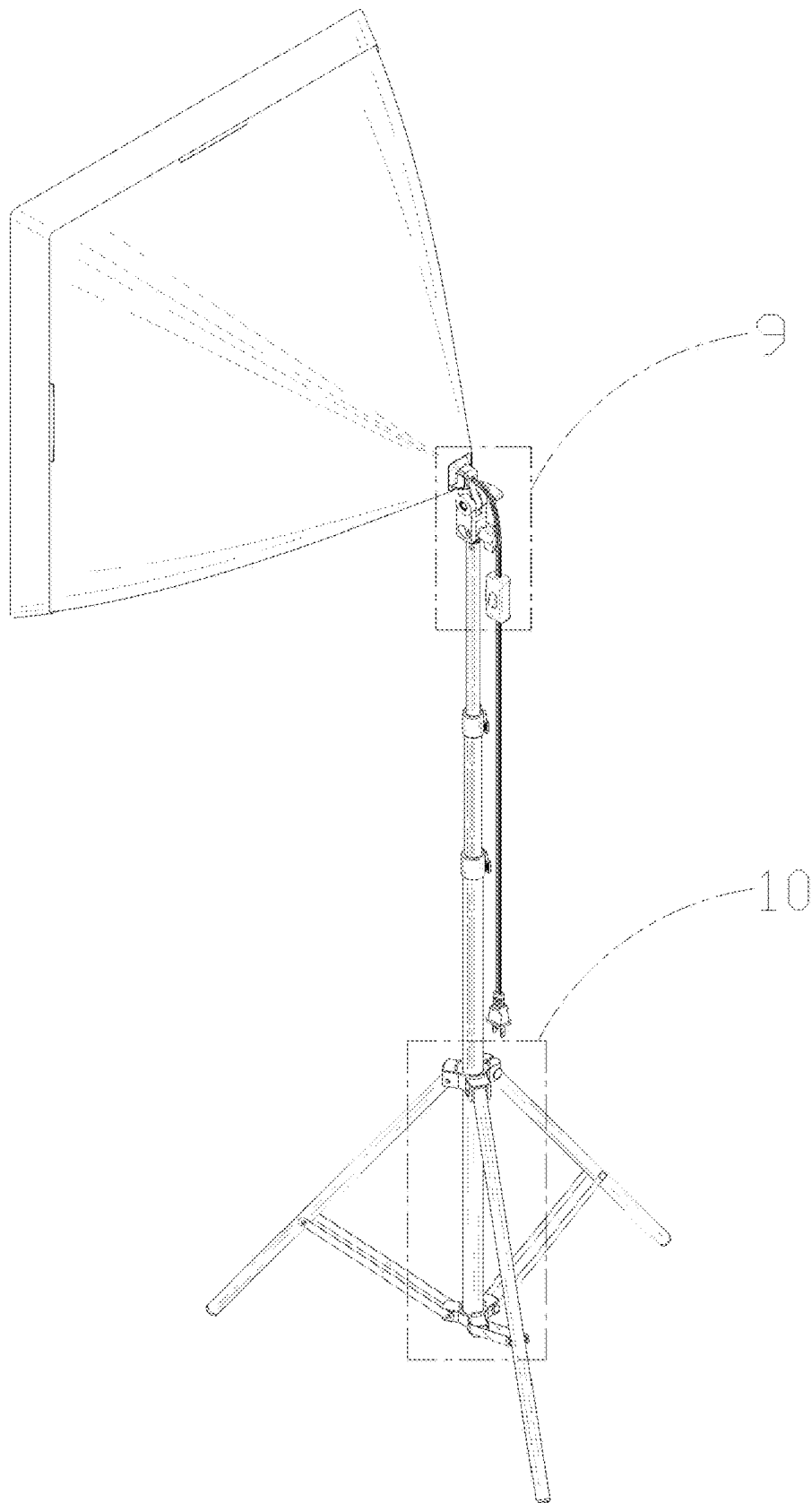

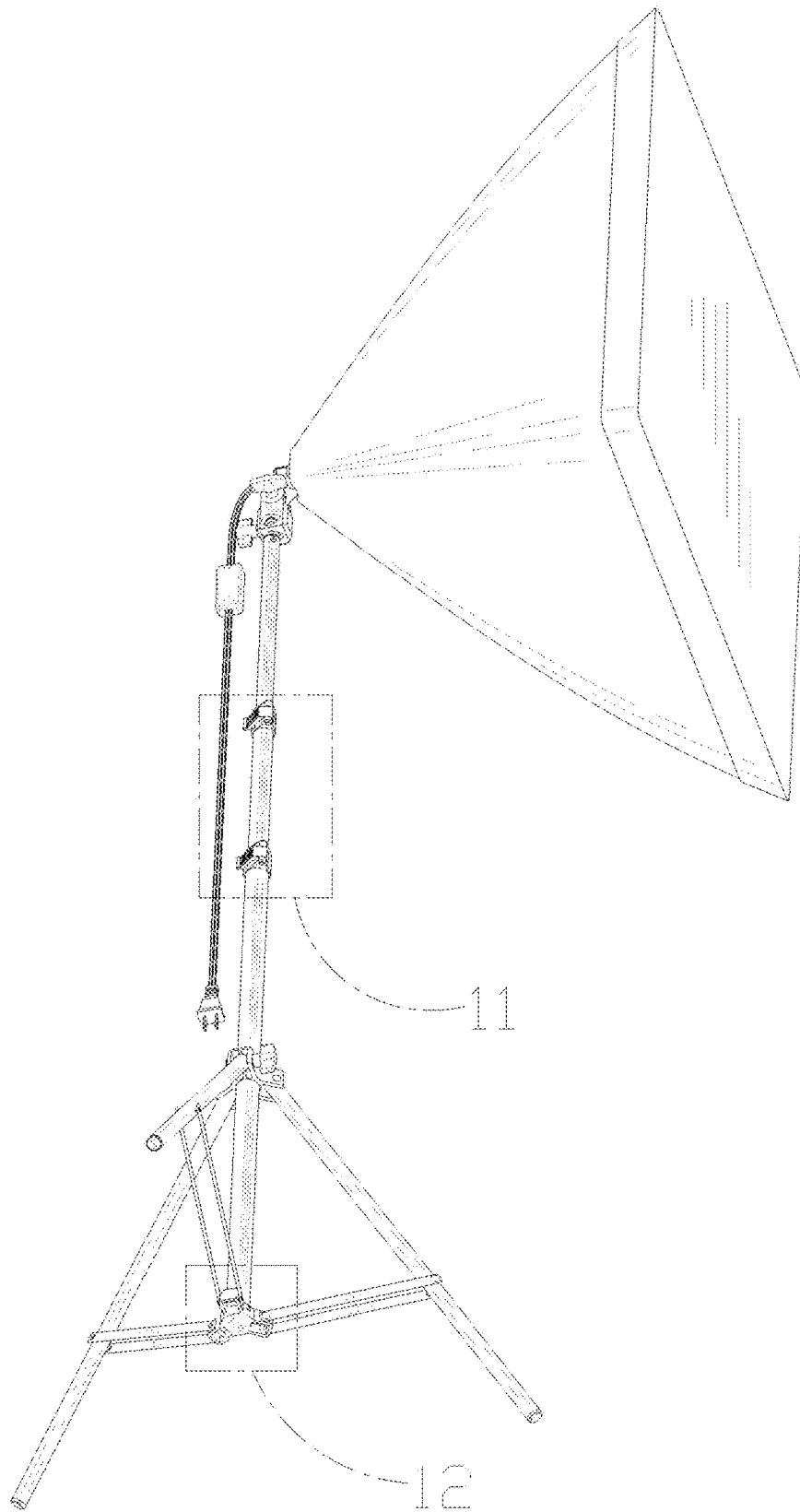

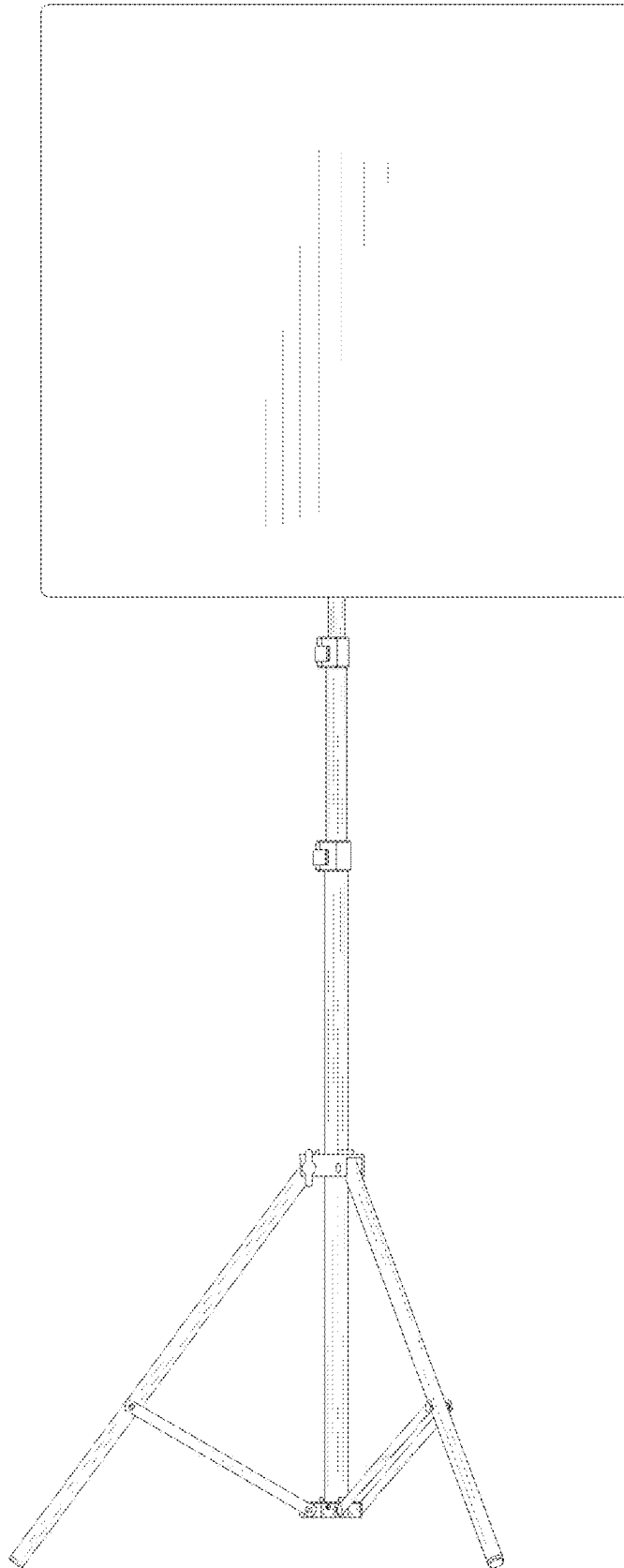

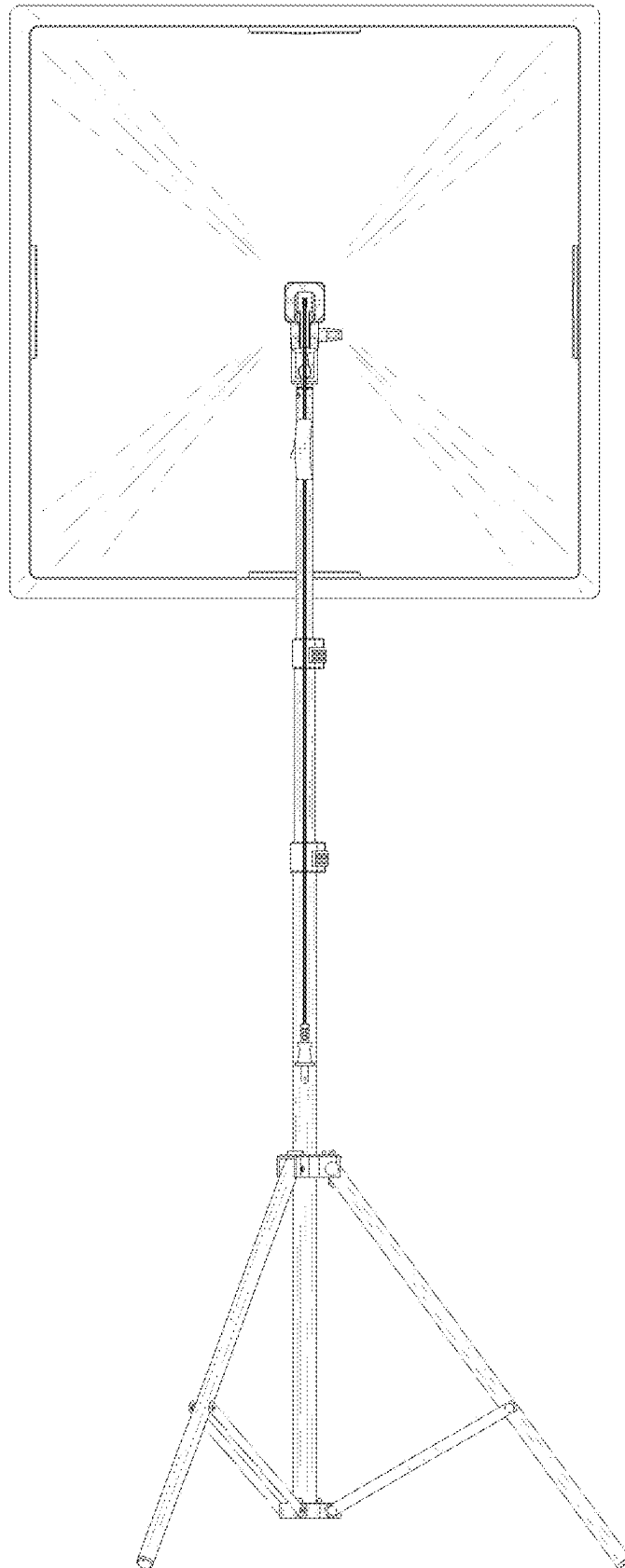

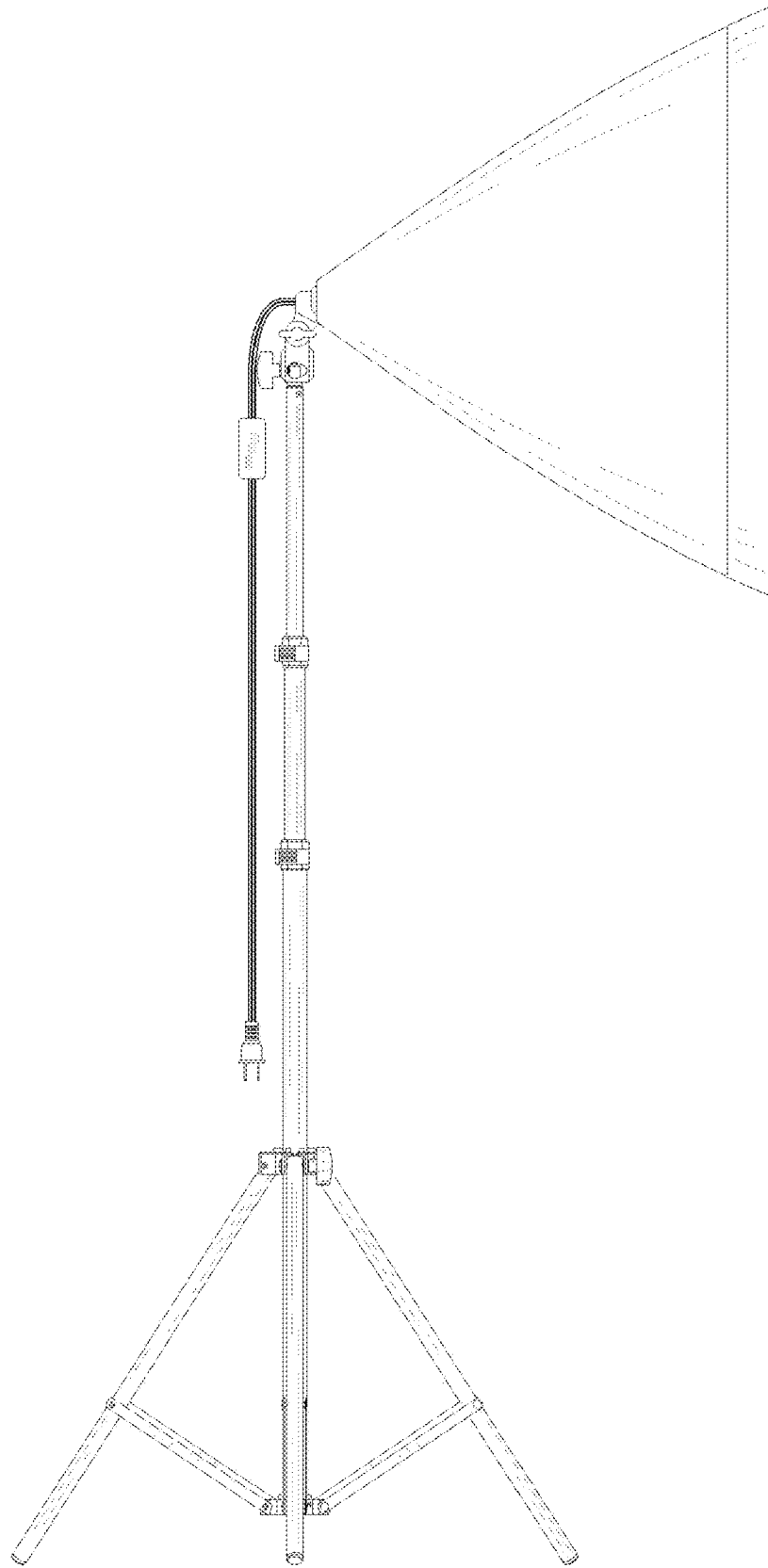

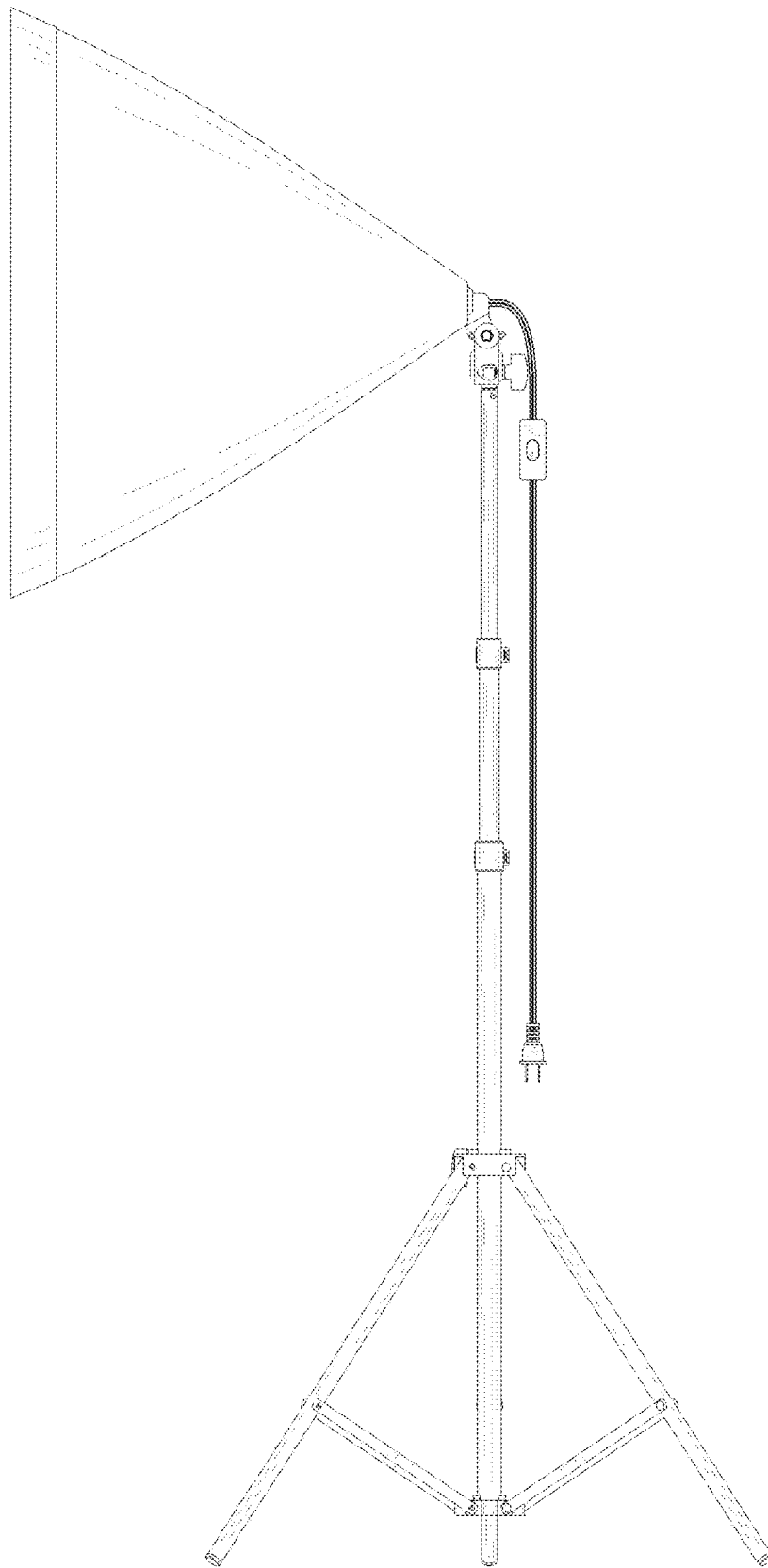

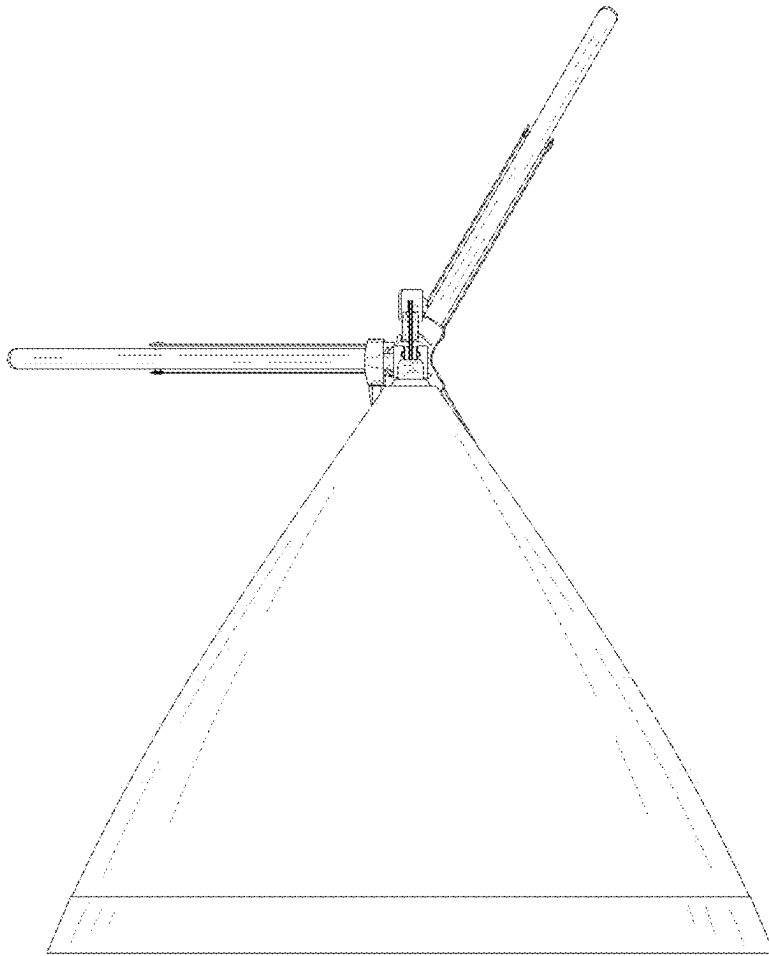

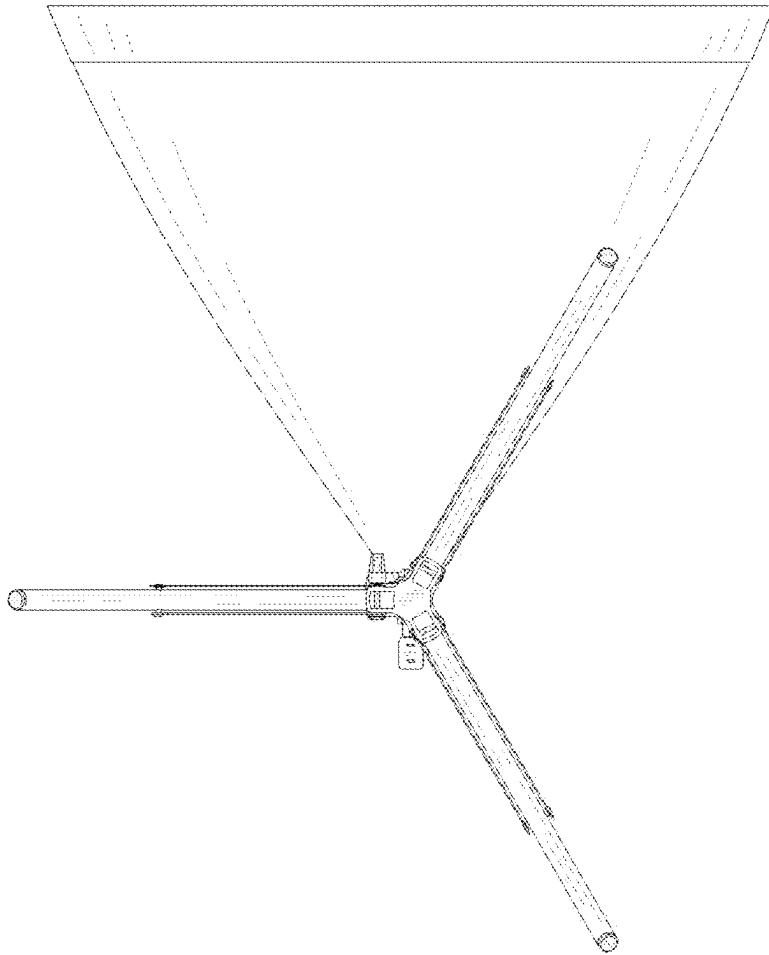

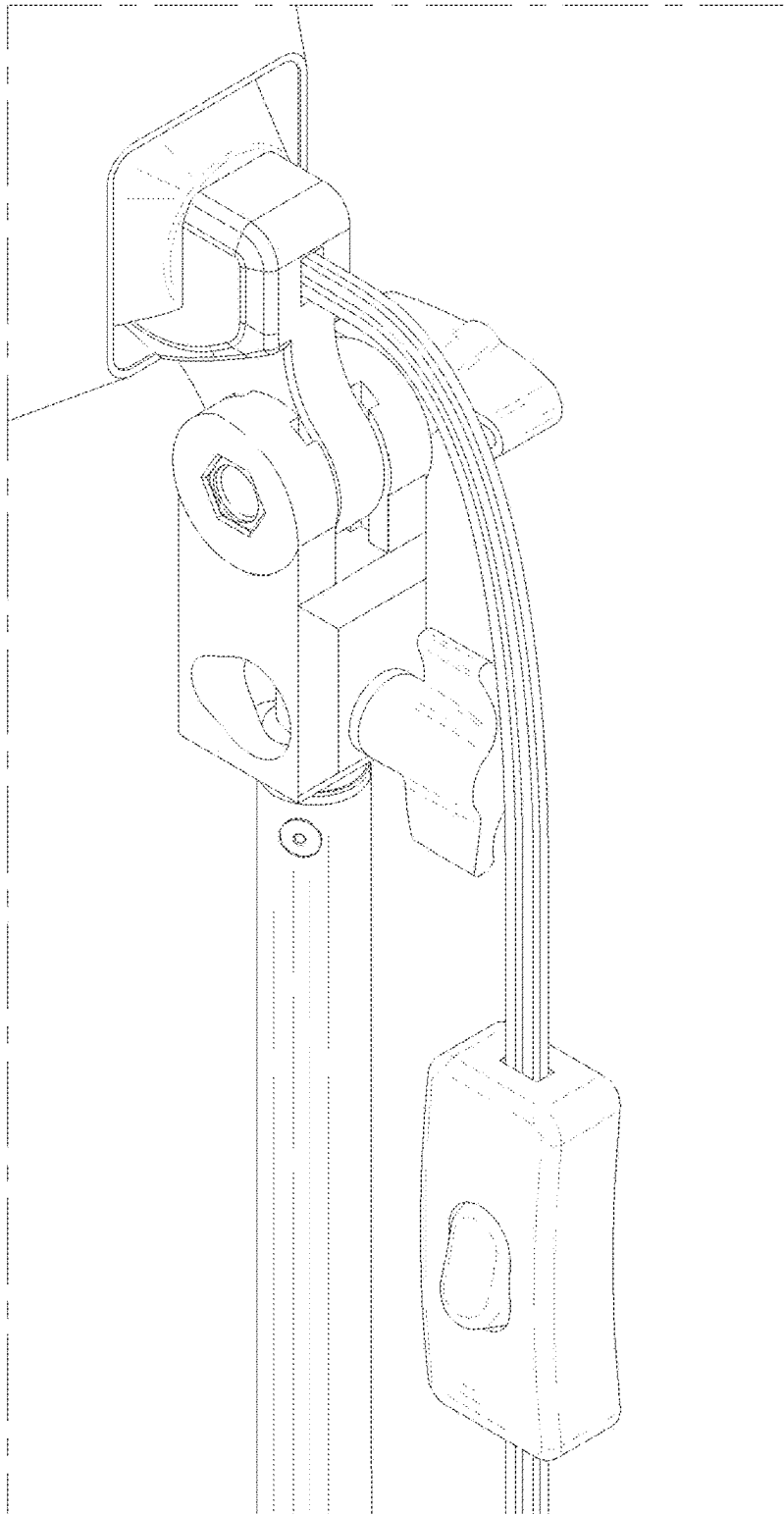

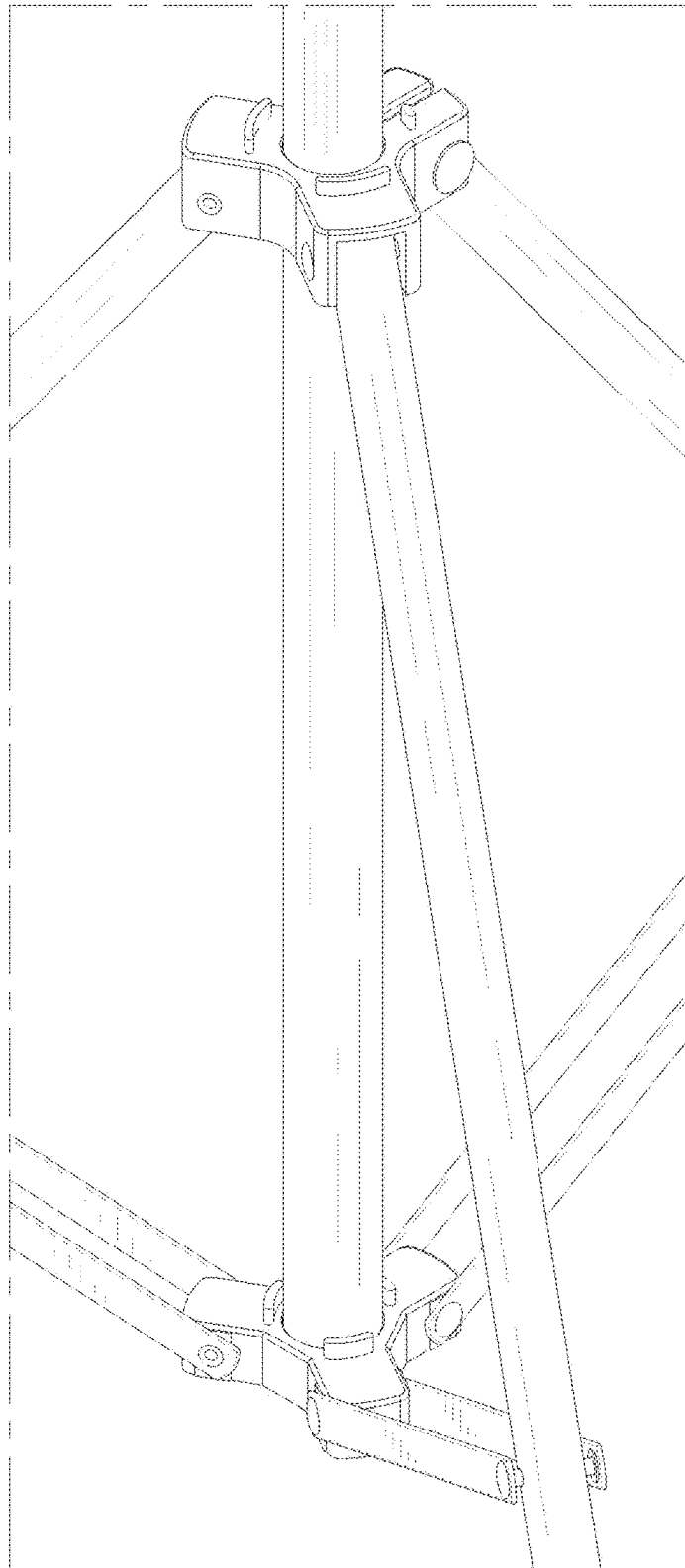

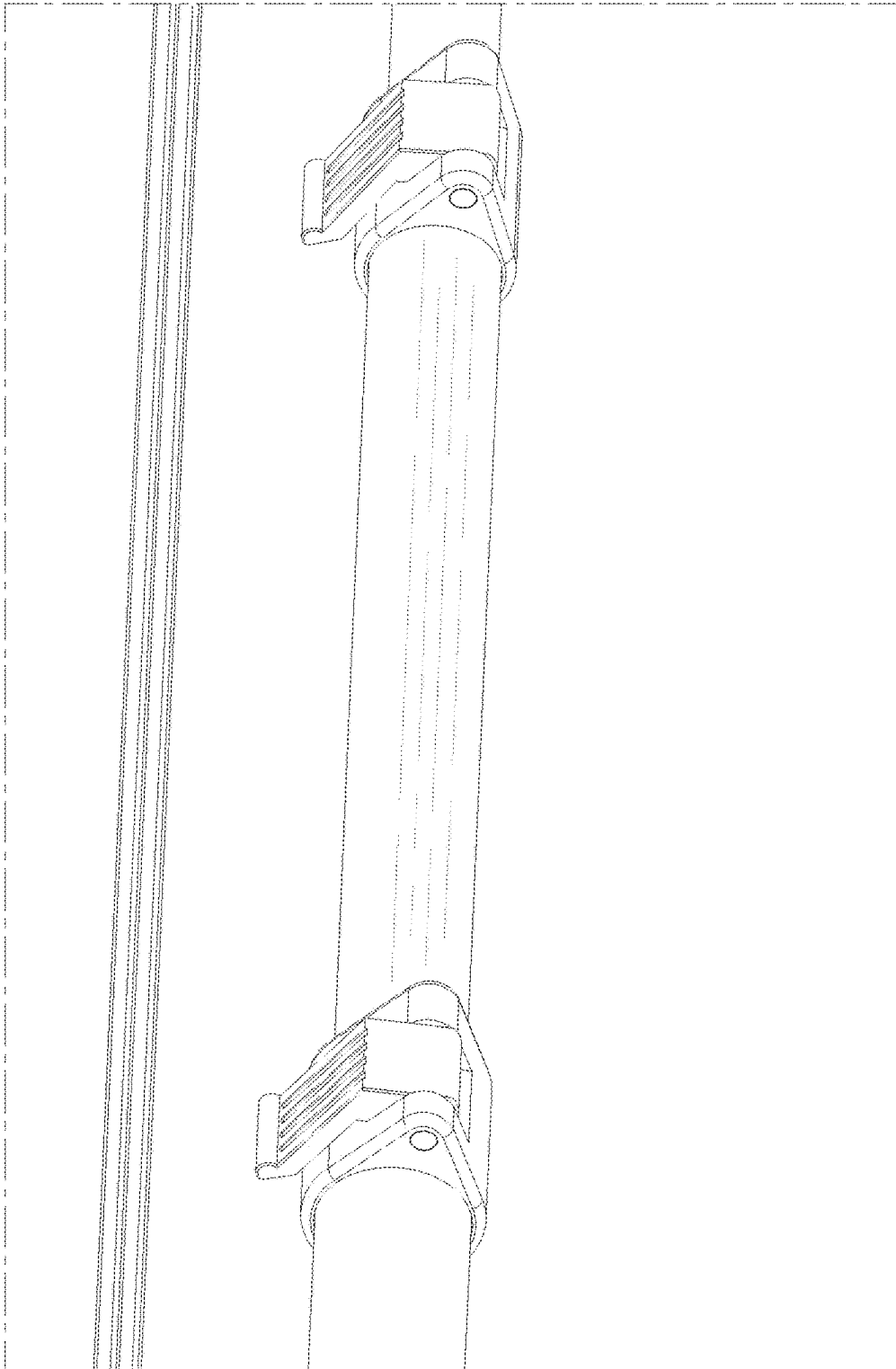

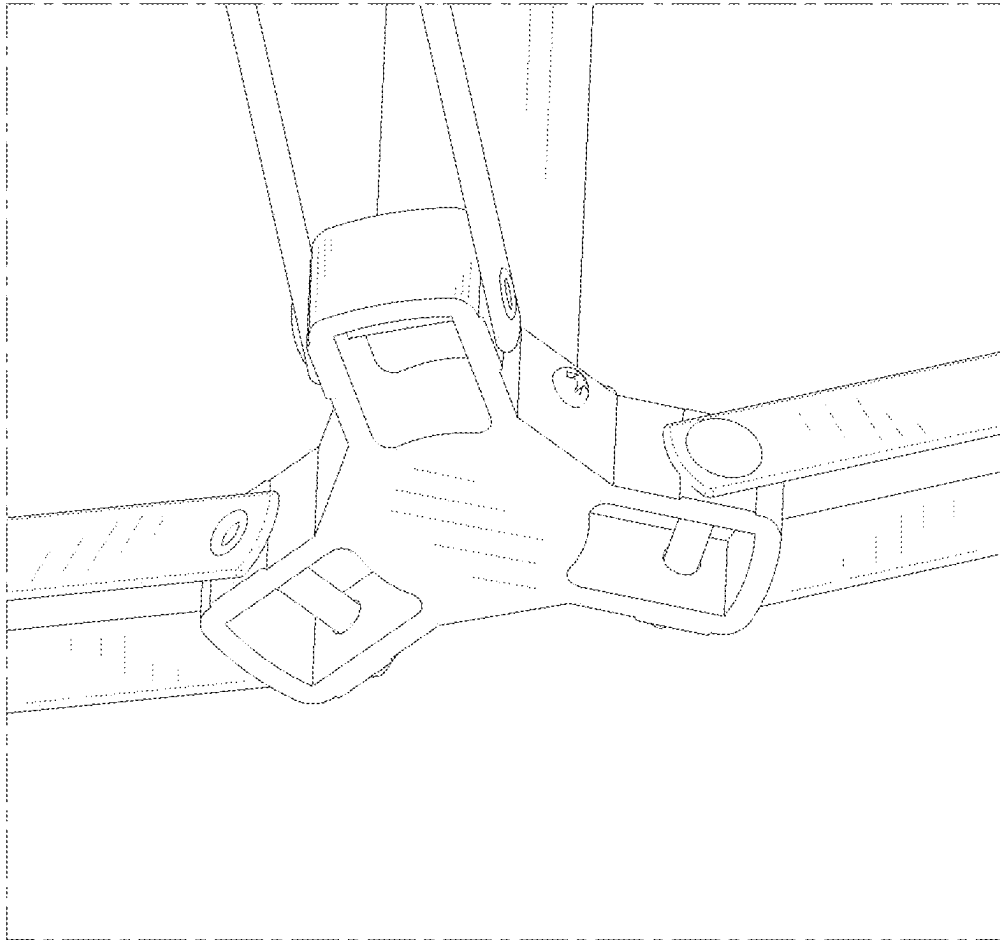
