**PETITIONER'S REQUEST FOR REFUND
OF POST-INSTITUTION FEES**

Petitioner Unimicron Technology Corp. (“Petitioner”) hereby files its request for a refund of the \$28,125.00 post-institution fee, which was previously paid.

On July 8, 2025, Petitioner filed a petition for inter partes review of U.S. Patent No. 8,368,201 and paid the USPTO a total of \$51,875.00, which included a \$23,750.00 payment for the inter partes review request fee, and a \$28,125.00 payment for the post-institution fee.

The petition was granted a filing date of July 8, 2025. (Paper No. 3). On November 20, 2025 the Board entered a Decision – Denying Institution of Inter Partes Review (Paper No. 7). Accordingly, the inter partes review was never instituted.

Therefore, because the petition to institute inter partes review was filed after March 19, 2013, and the proceeding did not institute, Petitioner is entitled to request a refund of the post-institution fee that was previously paid.
