ORDER

Granting Patent Owner's Unopposed Motion to Withdraw Counsel
37 C.F.R. §§ 42.10(e), 42.20(b)

On April 30, 2026, Patent Owner Maxell, Ltd. (“Patent Owner”) moved to withdraw from this proceeding the following counsel of Mayer Brown LLP: Robert G. Pluta, who is currently lead counsel for Patent Owner, and Amanda S. Bonner, Saqib J. Siddiqui, and Daniel Kim, who are currently back-up counsel for Patent Owner. Patent Owner previously sought and obtained authorization from the Board to file the motion. *See* Ex. 3004. The motion indicates that new lead counsel for Patent Owner will be Scott M. Patent Owner represents that Petitioners Samsung Electronics Co., Ltd. and Samsung Electronics America, Inc. do not oppose the motion and that the substitution of counsel will not have an adverse effect on Patent Owner or otherwise delay these proceedings. Mot. at 1.

In light of these representations by Patent Owner, it is hereby ORDERED that Patent Owner’s motion to withdraw counsel is granted. It is further ORDERED that Patent Owner shall file updated Mandatory Notices and a Power of Attorney upon receipt of this order.
