Dear Jeon-san,

We write to follow-up from our prior email exchange of August 2021 when we had completed execution of the NDA and decided to setup a time for a teleconference. As a next step to continue our discussions, Maxell would like to setup a teleconference with Samsung in early 2022 relating to discussions over a patent license agreement for Maxell’s patent portfolio, which covers various features of Samsung’s smartphones, tablets, watches, televisions, and related hardware and software products.

While we work together to schedule a time for a teleconference, Maxell would like to call to your attention the following U.S. patents and allowed patent application that we believe are also being infringed by Samsung’s smartphones, tablets, smartwatches, and related hardware and software products. These are in addition to the patents we identified previously.
