Good Afternoon, Director:

Patent Owner submitted a 24-page Motion for Discretionary Denial under 35 U.S.C. § 314(a) in IPR2025-01339 and IPR2025-01366. Patent Owner did so well in advance of the October 5, 2025, deadline to do so.
