Pursuant to the Board's Notice of Filing Date Accorded to Petition and Time for Filing Patent Owner Preliminary Response authorizing the filing of this notice (Paper 5), Patent Owner Champion Power Equipment, Inc. respectfully notifies the Board of its intent to designate Scott P. Amy, a provisionally recognized PTAB attorney, as back-up counsel under 37 CFR § 42.10(c)(2) in IPR2025-01384. Patent Owner seeks the counsel of Mr. Amy due to his experience representing Patent Owner in related patent matters and his familiarity with the legal, substantive, and technical issues involved in this proceeding. Mr. Amy satisfies the requirements of a provisionally recognized PTAB attorney eligible for automatic *pro hac vice* admission. *See* 37 CFR § 42.10(c)(2)(i). He has been previously recognized *pro hac vice* in PTAB proceedings, and he has not subsequently been denied permission to appear *pro hac vice* in any proceeding.

The registered practitioner who will serve as lead counsel in this proceeding is Joseph W. Staley (Reg. No. 60,732).

The most recent prior proceedings in which Mr. Amy was recognized *pro hac vice* by order of the PTAB pursuant to a motion of the type described in 37 CFR § 42.10(c)(1) were IPR2017-00159, IPR2017-00770, IPR2017-00915, IPR2018-00707, and IPR2018-00708.

This notice is also accompanied by a certification in the form of a declaration executed by Mr. Amy (EX2087). In the declaration, Mr. Amy attests to satisfying all

requirements set forth by the Board for *pro hac vice* recognition of a provisionally recognized PTAB attorney. EX2087. ¶¶2, 12; *see also id.*, ¶3-11. Mr. Amy specifically attests that:

1. He is a member in good standing of the State of Georgia (EX2087, ¶3);
2. He has no suspensions or disbarments from practice before any court or administrative body (*id.*, ¶4);
3. None of his applications for admission to practice before any court or administrative body has ever been denied (*id.*; ¶5);
4. No sanctions or contempt citations has ever been imposed by any court or administrative body on Mr. Amy (*id.*, ¶6);
5. He has read and will comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials set forth in 37 CFR part 42 (*id.*, ¶7);
6. He will be subject to the USPTO Rules of Professional Conduct set forth in 37 CFR §§ 11.101 et seq. and disciplinary jurisdiction under 37 CFR § 11.19(a) (*id.*, ¶8);
7. He identifies all other proceedings before the Office for which he has applied to appear *pro hac vice* in the last three years (*id.*, ¶9);
8. He has legal familiarity with the subject matter at issue in the proceeding (*id.*, ¶10).

Patent Owner therefore submits that Mr. Amy has satisfied all requirements to be deemed admitted *pro hac vice* in this proceeding.
