1 IT IS FURTHER ORDERED that this case is referred to private mediation. By February  
2 21, 2025, the parties shall hold an initial ADR session with their chosen mediator. Within seven  
3 days after the initial ADR session, the parties shall file a joint status report identifying the parties'  
4 mediator and confirming that the initial ADR session was completed. The status report shall state  
5 the outcome of the session and the parties' proposals for further ADR efforts if the initial ADR  
6 session was unsuccessful.

7 IT IS FURTHER ORDERED that a claims construction tutorial is scheduled for April 29,  
8 2025, at 2:00 p.m. via Zoom video. A claims construction hearing is scheduled for May 6, 2025,  
9 at 2:00 p.m. in person. The parties shall meet and confer regarding the format, scope, and content  
10 of both the tutorial and the claim construction hearing, including but not limited to the permissible  
11 subjects of discussion at each, whether experts will testify, and what audio-visual equipment, if  
12 any, will be needed by the parties.


