Petitioner's Request for Refund of Post-Institution Fees

1. Petitioner filed the Petition for *Inter Partes* Review of U.S. Patent No. 9,737,072 on August 27, 2025. At that time, Petitioner deposited with the PTAB the *inter partes* request fee and *inter partes* post-institution fee, for a total amount of \$51,875.
