**PATENT OWNER ENVIRO TECH CHEMICAL SERVICES, INC.'S

Pursuant to 37 C.F.R. § 42.8(a)(2), Patent Owner Enviro Tech Chemical Services, Inc. (“EnviroTech”) hereby provides the following information associated with its mandatory notices required by 37 C.F.R. § 42.8(b)(1)-(4).

I. Real Parties in Interest

Pursuant to 37 C.F.R. § 42.8(b)(1), Arxada Holdings NA Inc. is Enviro Tech's parent company, holding 10% or more of Enviro Tech's stock.

II. Related Matters

Pursuant to 37 C.F.R. § 42.8(b)(2), *Enviro Tech Chemical Services, Inc. v. Clean Chemistry, Inc.*, No. 1:24-cv-01313, pending in the United States District Court for the Western District of Texas, is a related matter.

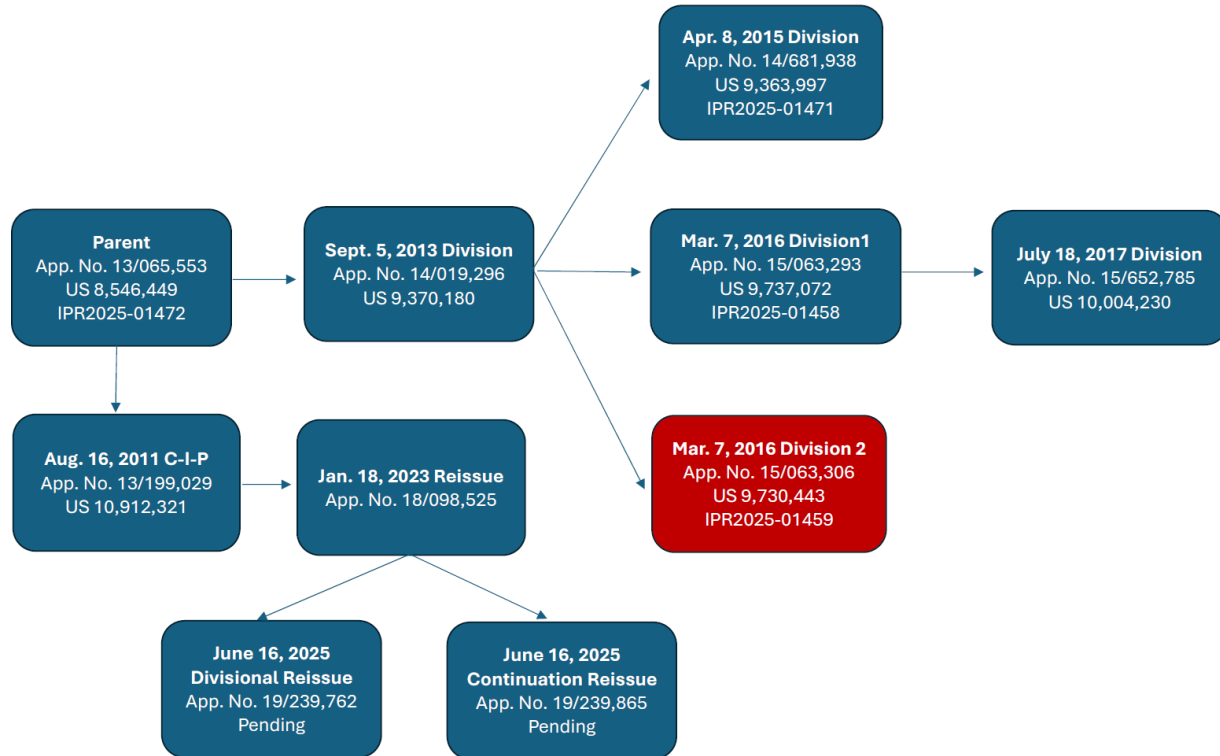
Patent Owner also identifies concurrently filed IPR2025-01458, IPR2025-01471, and IPR2025-01472, which relate to commonly-assigned U.S. Patent Nos. 9,737,072 (“‘072 Patent”), 9,363,997 (“‘997 Patent”), and 8,546,449 (“‘449 Patent”), respectively. For clarity, the ‘449 Patent is the parent patent of the U.S. 8,546,449 Patent Family. The present patent, U.S. Patent No. 9,730,443 (“‘443 Patent”), as well as the ‘072 and ‘997 Patents are divisionals of the ‘449 Patent.

In addition, U.S. Patent No. 10,912,321 (“‘321 Patent”), a continuation-in-part of the ‘449 Patent and a member of the U.S. 8,546,449 Patent Family, is currently the subject of an appeal to the Federal Circuit in *Enviro Tech Chemical*

Services, Inc. v. Safe Foods Corporation, Appeal No. 2024-2160. The '321 Patent is also the subject of a declaratory judgment action, *Zeco, LLC v. Enviro Tech Chemical Services, Inc.*, No. 1:21-cv-00079, which is pending in the Eastern District of Tennessee, and stayed pending the decision of the Federal Circuit in Appeal No. 2024-2160. Patent Owner does not believe that any of these actions would “affect, or be affected by” a decision in the current proceeding as required by 37 C.F.R. § 42.8(b)(2).

There are also three pending patent applications in the U.S. 8,546,449 Patent Family, each of which is related to the '321 Patent: (1) Application No. 18/098,525 (“'525 Application”), which is a reissue of the '321 Patent; (2) Application No. 19/239,762, which is a divisional reissue of the '525 Application; and (3) 19/239,865, which is a continuation reissue of the '525 Application. Prosecution of the '525 Application is currently suspended in light of Appeal No. 2024-2160. However, Patent Owner does not believe that any of these pending applications would “affect, or be affected by” a decision in the current proceeding as required by 37 C.F.R. § 42.8(b)(2).
