RE: MyPort IP, Inc. Notice of Infringement and Invitation for Licensing Discussions (U.S. Patent Nos. 9,832,017, 10,237,067, and 10,721,066)

Dear Jeff:

I hope you are well, particularly in these uncertain times.

We have recently been retained by MyPort IP, Inc. regarding the above listed U.S. patents. MyPort IP owns the patent family, which includes six more active U.S. patents and two pending continuations. Enclosed are copies of the '017, '067, and '066 patents. Information regarding these patents and their family members is publicly available, including via the U.S. Patent and Trademark Office's Public PAIR website. *See, e.g.*, U.S. Patent Nos. 8,509,477, 8,983,119, 9,070,193, 9,589,309, 9,922,391, and 10,387,986; U.S. Appl. Serial Nos. 16/900,058 and 16/543,293.

As shown on the enclosed claim charts, multiple products sold by Apple infringe one or more claims of the patents. So far, we have confirmed that Apple's iPad, iPad mini, iPhone, and iPod Touch infringe at least the following claims: '017 patent claims 13-17; '067 patent claims 6-9 and 13-17; and '066 patent claims 13-17.

You should also be aware that MyPort IP and Apple engaged in licensing discussions in 2011. Among other things, MyPort's and Apple's respective counsel met on September 30, 2011, to discuss licensing the patent family. At the time, Apple expressed interest in reaching a business solution, but the talks were suspended while MyPort engaged in litigation with other parties. Since then, MyPort IP has settled litigation in the Eastern District of Texas concerning the patent family and entered into licenses with several manufacturers of devices including Huawei Technologies Co., Ltd., Research in Motion Ltd., and Motorola Mobility, Inc.

MyPort would like to re-engage with Apple to see if a license agreement can be reached. Once you've had a chance to review the enclosed materials, perhaps we can schedule a call in November to discuss potential terms. While we are hopeful that we can reach a negotiated agreement, MyPort IP reserves any and all rights. In particular, any communication, noncommunication, and/or inactivity should not be relied upon as, among other things, acquiescence, waiver or compromise of any of MyPort's rights.
