The '066 Patent and '017 Patent share a similar specification. MyPort accuses Petitioner of infringing the '017 Patent in Case No. 1:24-cv-01337 (D. Del. Dec. 6, 2024) as well.
- *Apple Inc. v MyPort Technologies, Inc.*, IPR2025-01467, filed September 9, 2025, involving U.S. Patent No. 11,188,998, which is a continuation of patents and/or patent applications that the '066 Patent is related to. MyPort accuses Petitioner of infringing the '998 Patent in Case No. 1:24-cv-01337 (D. Del. Dec. 6, 2024) as well.
- *Samsung Electronics Co., Ltd. v. MyPort, Inc.*, IPR2023-00023, filed October 7, 2022. Involved the '017 Patent. Terminated before trial based on settlement between the parties.
- *Samsung Electronics Co., Ltd. v. MyPort, Inc.*, IPR2023-00024, filed October 7, 2022. Involved the '067 Patent. Terminated before trial based on settlement between the parties.

- *Samsung Electronics Co., Ltd. v. MyPort, Inc.*, IPR2023-00025, filed October 7, 2022. Involved the '066 Patent. Terminated before trial based on settlement between the parties.
- *MyPort, Inc. v. Samsung Electronics Co., Ltd. et al.*, Case No. 2:22-cv-00114, filed April 15, 2022. Involved the '017, '066, and '067 Patents. Dismissed before trial based on settlement between the parties.
