PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEE

Petitioner Apple Inc. (“Petitioner”) hereby files its request for a refund of the \$28,125.00 post-institution fee. The \$28,125.00 *inter partes* review post-institution claim fee for up to twenty (20) claims was previously paid.

On September 9, 2025, Petitioner filed a petition for *inter partes* review of U.S. Patent No. 10,721,066 and paid the USPTO a total of \$51,875.00, which included a \$23,750.00 payment for the *inter partes* review request fee and a \$28,125.00 payment for the post-institution fee up to twenty (20) claims.

The petition was granted a filing date of September 9, 2025. (Paper No. 3). On January 9, 2026 the Board entered a Notice of Decisions on Institution (Paper No. 11) which after review of discretionary considerations denied institution. Accordingly, the *inter partes* review of U.S. Patent No. 10,721,066 was never instituted.

Therefore, because the petition to institute *inter partes* review was filed after March 19, 2013, and the proceeding did not institute, Petitioner is entitled to request a refund of the post-institution fee that was previously paid. *See, e.g.*, 78 FR 4233 (Jan. 18, 2013) available at <http://www.gpo.gov/fdsys/pkg/FR-2013-01-18/pdf/2013-00819.pdf> (“The entire post-institution fee would be returned to the petitioner if the Office does not institute a review.”).

Petitioner hereby requests a refund of the \$28,125.00 post-institution fee previously paid by Petitioner. The refund may be deposited in Deposit Account No.
