Dear Judge Albright,

As instructed Friday, the parties inform the Court of the agreed claims construction issues and those still requiring guidance or a ruling.

- “third party provider”: The parties agree with the Court’s preliminary construction of “plain and ordinary” meaning.
- “cellular core network”: The parties request that the Court construe this term on the briefing.

- “bearer”: The parties propose the Court construe this term to have its “plain and ordinary” meaning.
- “wherein . . . when”: The parties have differing positions on what the plain and ordinary meaning for these four terms should be. If the Court chooses to wait for a fuller summary judgment record to decide that issue, the parties can proceed with discovery and the issue can be postponed to the summary judgment phase. If the Court would like to decide that issue now, the parties are prepared to supply the Court with additional briefing or a hearing, if requested.
